❖ PROVIDING OF WATER TANKER ON LEASE/RENTAL BASIS

- 1. Contract period one year from September 2017 to August 2018**
2. Contractor along with tanker shall provide driver with valid license for the tanker. Contractor shall ensure that, driver is not suffering from color blindness/ night blindness.
3. Vehicle should be less than 10 years old.
4. No idling charges will be paid by the company.
5. In case of failure /breakdown of vehicles, the contractor has to make an alternative arrangement to avoid delay.
6. The supplier has to deposit an amount of Rs. 15,000/- as security deposit (in case of placement of order) and the same will be returned after the expiry of the contract.
7. Party shall submit Updated emission test certificate from appropriate authority from time to time upon expiry of old and driving licence should be produced whenever required.
8. Party shall submit valid vehicle fitness certificate before receiving the order and also submit new fitness certificate upon expiry of old fitness certificate. In case non-submission of the same HLL has right to cancel the contract & forfeit EMD/ security Deposit.
9. Party should quote monthly rental charges for 12 KL, 16 KL & 20 KL capacity tanker separately GST %should be clearly mentioned.

12. After finalization of bids, HLL shall enter into contract (with successful bidders) along with security deposit.
13. In case of vehicle breakdown, alternate arrangement to be made by the contractor.
14. Rate quoted should be inclusive of all expenses like maintenance, salary, statutory payment etc.
15. 20% of annual procurement value will be sourced from Micro and Small Enterprises (MSE), out of which 4% is earmarked for procurement from MSE's owned by SC or ST entrepreneurs. In the event of failure of SC or ST entrepreneurs to participate in tender or meet tender requirements /conditions regarding price the same will be sourced from other MSE enterprise.
16. However, SSI units who wish to avail exemption against payment of EMD should produce an exemption certificate issued by the concerned DIC or NSIC stating that the SSI unit should be exempted from payment of EMD in respect of the relevant Tender No. Indicated in the tender document.
17. EMD of Rs. 2,000/- (Rupees Two Thousand Only) should be submitted along with the quotation by way of demand draft drawn in favour of M/s. HLL Lifecare Limited, Kanagala payable at Nipani. Tenders without EMD will be liable for rejection.
