### General Instructions to Applicants

1. HLL Lifecare Limited (HLL) ,Poojappura,Kerala,a Government of India enterprise under Ministry of Health & Family Welfare, invites, Request for Empanelment (RFE) from **Consultants/Consulting Firms For Imaging Equipment** initially for a period of one year extendable upto three years by the competent authorities of HLL based on satisfactory performance of the empanelled consultant(s)/Consulting firm(s).
2. The criteria and actual process of evaluation of the responses to this RFE and subsequent selection of the Consultants/Consulting Firm(s) will be as mentioned in this Request for Empanelment (RFE) and any modification or changes in the terms and conditions mentioned in this RFE will be entirely at the discretion of HLL.
3. No contractual obligations, whatsoever, shall arise from this Request for Empanelment (RFE) process unless and until a formal contract is signed and executed by duly authorized official(s) of HLL with the selected Consultants/Consulting Firm(s). HLL reserves the rights to empanel one or more firms/consultants.
4. The content of this RFE enlists the requirements of the HLL. It includes the Empanelment Terms which details out all that may be needed by the firms to understand the terms and the empanelment process and explain the contractual terms that the HLL wishes to specify at this stage.
5. Interested agencies are advised to study this RFE document carefully before submitting their proposals in response to the Empanelment notice. Submission of a proposal in response to this notice shall be deemed to have been done after careful study and examination of this document with full understanding of its terms, conditions and implications.

## Section c

### Instructions to Applicants (ITA)

#### **1. About Us –HLL Lifecare Limited**

HLL Lifecare Limited (HLL) is a Govt. of India Enterprise, under the Ministry of Health & Family Welfare. While focusing and expanding the core areas of its operation i.e. reproductive healthcare, HLL diversified into other healthcare segments like hospital products, hospital infrastructure management, medical equipment procurement consultancy, diagnostic services, retailing of pharmaceuticals etc. The purpose of business at HLL is 'to provide high-quality products and services at affordable prices'.

As part of HLL's Procurement Consultancy Services, HLL has a Sourcing Division (SD) which functions as a centralized procurement entity of various other HLL business divisions.

From time to time, HLL SD procures medical & imaging equipments, surgical instruments and implants, on behalf of many institutions across India for HLL Business Divisions. The SD procurement process follows open tender two bid system published through GEM/CPP portal for the procurement of items and the bids of technically qualified applicants approved by a technical committee is opened for financial evaluation.

#### **2. Empanelment of Consultants**

To facilitate the technical evaluation of such high value items, it is proposed to empanel a pool of experts, as consultants with strong technical expertise in operation and working of Imaging Equipment such CT, MRI, PET, Doppler, Ultrasound, Xray/ECG, Laproscopy etc.

The above list is indicative only and consultants having expertise in any relevant field other than those mentioned above and related to Medical & Healthcare devices and equipments can also apply for empanelment. The empaneled consultants will then be engaged by SD to independently evaluate the bid documents for compliance and accordingly qualify bid submissions.

#### **3. Scope of Work**

1. Review the HLL tender documents, including technical specifications, drawings, and terms and conditions.
2. Evaluate bids received against the technical criteria specified in the tender documents.
3. Assess the technical capabilities of the applicants, including their experience, expertise, and proposed methodologies.

4. Provide a detailed report on the evaluation, highlighting strengths, weaknesses, and any concerns or recommendations.

#### **4. Operationalization of Consultancy**

1. The consultants would be engaged from time-to-time on “**as and when required basis**” as per the scope of work determined by HLL SD. The detailed terms & conditions for the same shall be worked out separately after technical evaluation. Consultancy fees would be paid on the basis of the projects /manhours/days etc on active engagement through Empanelment.
2. The empanelled consultants/firms shall be considered as independent contractors with only temporary need-based engagement.
3. The copyright and IPR of any material produced under provision of the consultancy would rest solely with HLL.
4. Consultancy fees would be paid in consideration of their project-based services in phases as per finalization of their project work on active engagement through Empanelment.
5. While the above-mentioned activities are to give an idea about the nature and type of projects, there can be any additional activities of similar nature, which the empanelled firms/companies/consultants would be required to undertake, based on the requirements from time to time.
6. **The quality of the services is extremely critical and as part of their proposal the consultants/ consulting firms/proposer should demonstrate core competencies/ strengths on the above key aspects including adherence to quality and timely execution.**

#### **5.Pre- Qualification Criteria**

The Consultants/Consulting Firms For Imaging Equipment are expected to meet the following prequalification criteria. Consultants/Consulting Firms For Imaging Equipment failing to either meet these criteria or not furnishing the requisite supporting documents/documentary evidence is liable to be summarily rejected. HLL shall evaluate the pre-qualification proposal with reference to the information and supporting documents furnished,

## **6. Technical Evaluation (100 Marks)**

The Technical Evaluation would happen on the basis of Consultants/Consulting Firms For Imaging Equipment relevant experience and key personnel as described under. Technical submissions should contain signed and scanned soft copy documents in proof of experience and **duly filled and signed copy of documents specified.**

Applicants will be considered qualified, if they score a total of 75% in technical evaluation.





## Section D

### General Conditions Of Contract

HLL shall keep a data bank of the eligible/qualified consultants/firms. The consultant or its associates/companies who are engaged by HLL for the aforesaid scope of work are not allowed to use the name of HLL, its logo, service marks or any document for any purpose without the prior written approval of HLL.

- i. HLL reserves the right to (a) reject any/all proposals without assigning any reasons thereof, (b) relax or waive off any of the conditions stipulated in this RFP document as deemed necessary in the best interest of HLL and the objectives of the project without assigning any reasons thereof and (c) include any other item(s) in the Scope of work at any time after consultation.
- iii. **Intellectual Property Rights:** All intellectual property rights developed as a consequence of any allotment of work to the subsequent empanelled consultant shall be the sole property of HLL and shall be governed by the provisions of the agreement/work order issued thereto.
- iv. **Blacklisting/debarring:** HLL reserves the right to cancel the empanelment letter issued and debar the firm, if it is found that the firm had produced any false information, on continued delivery of unsatisfactory services, insolvency of the company or any other ethical ground as deemed fit by giving a 07 days prior written notice.
- v. **Allocation of work post empanelment:** The allocation of work post empanelment among all the empanelled agencies will be made based on requirement as and when the requirements arise.
- vii. **Amendment to RFE:** At any time prior to the last date for receipt of applications, HLL may for any reason, whether at its own initiative or in response to a clarification requested by a prospective applicant, modify the RFE document by an amendment. In order to provide prospective applicants reasonable time in which to take the amendment into account in preparing their proposals, HLL may at its discretion extend the last date for the receipt of proposals and/or make other changes in the requirements set out in the RFE. **The applicant is required to visit the Tender Section of HLL on its website (<https://www.lifecarehll.com/tender>) for any changes or amendments in the RFE before submitting their Applications.**
- viii. **Ethics:** HLL expects all operators, shortlisted Consultants/Consulting Firms For Imaging Equipment to show highest ethical standards during the course of the assignment. If any complaints/information regarding any incident of malpractices (bribery, seeking monetary or non-monetary favour/gifts) is brought to the notice, the shortlisted Consultants/Consulting Firms For Imaging Equipment shall take the necessary action (to the extent of expulsion/removal) as per its organization rules and laws applicable at that time. HLL is absolved of any liability/claim arising out of any of the situations mentioned herein.

- ix. **Confidentiality:** The Consultants/Consulting Firms For Imaging Equipment must not divulge any confidential information and assure that reasonable steps are taken to provide for the safe custody of any and confidential information in its possession and to prevent unauthorized access thereto or use thereof. The shortlisted Consultants/Consulting Firms For Imaging Equipment must not, without the prior written consent of HLL, disclose any confidential information of HLL or any government department or relating to any ministry or any other party. In giving written consent to the disclosure of confidential information, HLL may impose such conditions as it thinks fit, and the Consultants/Consulting Firms For Imaging Equipment must comply with these conditions. Confidentiality clause shall survive for a longer period of one year after the termination of contract or contract expiry period. The selected Consultants/Consulting Firms For Imaging Equipment will be required to sign a mutually agreed Non-Disclosure Agreement (NDA) with HLL. During evaluation, HLL may, at its discretion, ask the respondents for clarifications on their proposals. The firms/agencies/Individuals are required to respond within the time frame prescribed by HLL.
- x. The proposals submitted by the firms/agencies shall remain valid for a period of **six months after the closing date (deadline)** for submission of proposals prescribed in this document.
- xi. HLL may at its sole discretion and at any time during the evaluation of proposal, disqualify any respondent, if the firm:-
- a) Submitted the proposal after the response deadline.
  - b) Made misleading or false representations in the forms, statements and attachments submitted in proof of the eligibility requirements.
  - c) Submitted a proposal that is not accompanied by required documentation or is nonresponsive, failed to provide clarifications related thereto, when sought.
  - d) Submitted more than one proposal.
  - e) Was declared ineligible by the Government of India/State/UT Government for corrupt and fraudulent practices.
- xii. The application/bid is liable to be rejected if:
- a) Not in prescribed forms and not containing all required details.
  - b) Not properly sealed and signed as per requirements.
  - c) Received after the expiry of due date and time.
  - d) Missing of any supporting document(s) with the Proposal.
