7.	TDS @ 2% shall be deducted on the basic price of the rental charges of both Manpower & Equipment.														
8.	NSIC vendors are exempted from both tender fees & EMD. However, a valid NSIC certificate with the details of service rendered to be submitted along with the technical bid and the same shall be evaluated at the time of technical bid opening.

Clause : 48 HLL BIOTECH LIMITED may, at any time, at his option cancel and terminate this contract by written one month notice on either party stating reasons for such cancellation or termination to the Contractor, in which event the Contractor shall be entitled to payment for the work done up to the time of such cancellation.														
10.	Page 33/77. Clause : E 3 The bidder should be able to depute their manpower within 15 days from the date of receipt of service order.														
11.	The liability of the Contractor under the contract is limited to the contract value. The limitation of the liability of the contractor under this contract shall not prevent the Employer/HBL to claim compensation for damages arising out of gross negligence or willful misconduct of the defaulting contractor.														
12.	Page 31/77. Clause: B. i. g Cleaning of facet will be under the scope of contractor. Scissor fork lift for cleaning shall be provided by HBL.														
13.	Page 31/77. Clause: B. ii. o The waste generated inside the premises to be moved/shifted to the identified dump yard by contractor within the premises.														

14.	Page 55/77 Point : viii Word Fencing shall be removed.
