B. THE BIDDING DOCUMENTS

3. Contents of Bidding Documents

3.1 The equipments required, bidding procedures and contract terms are prescribed in the Bidding documents

3.2 The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all information required by the Bidding Documents or submission of a bid not substantially responsive to the Bidding Documents in every respect will be at the Bidder's risk and may result in rejection of its bid.

4. Amendment of Bidding Documents

- 4.1 At any time prior to the deadline for submission of bids, the Purchaser may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the Bidding Documents by an amendment.
- 4.2 In order to allow prospective bidders reasonable time in which to take the amendment into account in preparing their bid, the Purchaser may, at its discretion, extend the deadline for the submission of bids

C. PREPARATION OF BIDS

5. Language of Bid

5.1 The Bid and all correspondence and documents relating to the bid shall be written in the English language. Supporting documents and printed literature written in any other language than English shall be accompanied by an accurate English translation of the relevant passages, in which case, for purposes of interpretation of the Bid, the English translation shall govern.

6. Documents Comprising the Bid

Following documents and forms are to be included in the technical bid and commercial bid respectively. All pages in the bid document submitted shall be confirmed by signature of the bidder/authorized signatory of the bidding firm with official seal.

6.1 TECHNICAL BID

7. Bid Prices.

- 7.1 The Bidder shall indicate in the Price Schedule the unit prices and total prices of the goods it proposes to supply under the Contract.
- 7.2 Prices indicated on the Price Schedule shall be entered separately in the following manner:
 - (i) The price of the goods, quoted ex-factory, ex-show-room, ex-warehouse, or off-theshelf and all duties and sales tax and other taxes.
 - (ii) Charges for inland transportation, insurance and other local costs incidental to delivery of the goods to and at final destination and up to commissioning and handing over the equipment on turnkey basis.
- 7.3 Fixed Price: Prices quoted by the Bidder shall be fixed during the Bidder's performance of the contract and not subject to variation on any account.
- 7.4 A bid submitted with an adjustable price quotation will be treated as non-responsive and will be rejected.

8. Bid Currencies

8.1 Prices shall be quoted in Indian Rupees.

9. Documents establishing bidder's eligibility and qualifications

- 9.1 The bidder shall furnish the documents to establish their eligibility to bid to the Purchaser's satisfactions
- 9.2 The bidder's documents shall include to establish legal status, place of registration and principle place of business of the company or firm or partnership, financial capability, eligibility criteria, experience and past performance during **last three years** as per proforma given in Section VIII.
- 9.3 Documents establishing goods conformity to bidding documents : Technical conformity Compliance Sheet with documentary evidence, may be in the form of literature, drawings and data, brand names or catalogue numbers and shall consist of :
 - (a) a detailed description of the essential technical and performance characteristics of the goods;
 - (b) Details of available sources and current prices of all spare parts, special tools if any may be necessary for the proper and continued functioning of the equipment for a period of five years.

10. **Period of Validity of Bids**

- 10.1 Bids shall be valid for **Six Months** from the date of opening of price bid
- 10.2 In exceptional circumstances, the Purchaser may solicit the bidders consent to an extension of the period of validity, in writing.

11. Format and Signing of Bid

- 11.1 The bid shall be typed or written in indelible ink and shall be signed in all the pages of the bid, except for un-amended printed literature, by the Bidder or a person(s) duly authorized by the Bidder. The tenders signed by the person other than the bidder shall accompany a letter of authorization from the original bidding authority.
- 11.2 Any interlineations, erasures or overwriting in the bid shall be valid only if they are initialed by the person(s) signing the bid.

D. SUBMISSION OF BIDS

12. Sealing and Marking of bids

Separate bids shall be submitted for price bid and technical bids as follows.

- (b) If the inner and outer envelopes are not sealed and marked as required, the Purchaser will assume no responsibility for the bid's misplacement or premature opening.
- (c) Bids should be received by the Purchaser at the address specified not later than the date and time specified in the Invitation For Bid. In the event of the specified date for the submission of bids being declared a holiday for the Purchaser, the bids will be received up to the appointed time on the next working day.
- (d) The Purchaser may, at its discretion, extend this deadline for the submission of bids by amending the bidding documents in which case all rights and obligations of the Purchaser and bidders previously subject to the deadline will thereafter be subject to the deadline as extended. 13. LATE BIDS

13.1 Any bid received by the Purchaser after the deadline for submission of bids, shall be rejected and returned unopened to the bidder.

14. MODIFICATION AND WITHDRAWAL OF BIDS

14.1 The bidder may modify or withdraw its bid after the bid submission, provided that written notice of the modification or withdrawal is received by the Purchaser prior to the deadline prescribed for submission of bids.

- 14.2 A withdrawal notice may also be sent by cable or fax, but followed by a signed confirmation copy, post-marked not later than the deadline for submission of bids.
- 14.3 No bid may be modified subsequent to the deadline for submission of bids.
- 14.4 No bid may be withdrawn in the interval between the deadline for submission of bids and the expiration of the period of bid validity specified by the bidder in the Bid Document.

E. BID OPENING AND EVALUATION

15. Opening of Bids by Purchaser

15.1 The Purchaser will open all technical bids (Cover A), in the presence of bidder's representatives who choose to attend, at 15.00 Hrs on 17/02/2016 at the following location:

- 15.2 In the event of the specified date of bid opening being declared a holiday for the Purchaser, the bids shall be opened at the appointed time and location on the next working day.
- 15.3 The purchaser will scrutinize the technical bid for compliance to the specifications and documentation requirement as per the bid document. On the basis of technical documents scrutiny, Purchaser, at its discretion and if deemed appropriate, may depute its competent persons to the premises of the qualified bidder for on-site evaluation of the claims made in the technical bid. The bidders will be short-listed on the basis of responsiveness of technical bid as well as report of on-site technical evaluation.
- 15.4 The price bid of the bidders who are disqualified at the technical scrutiny and onsite evaluation will be returned un-opened.
- 15.5 The "Price Bid" (Cover B) will be opened after evaluation of "Technical bids" (Cover A) and the date and time will be intimated to bidders whose bids are responsive and qualified in the Technical Bid.
- 15.6 The successful bidder shall be identified on the basis of lowest evaluated substantially responsive bid.

16. CLARIFICATION OF BIDS

16.1 During evaluation of bids, the Purchaser may, at its discretion, ask the bidder for a clarification of its bid. The request for clarification and the response shall be in

writing and no change in prices or substance of the bid shall be sought, offered or permitted.

17 PRELIMINARY EXAMINATION

- 17.1 The Purchaser will examine the bids to determine whether they are complete, whether any computational errors have been made, whether the documents have been properly signed, and whether the bids are generally in order.
- 17.2 Arithmetical errors will be rectified on the following basis. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected. If there is a discrepancy between words and figures, the amount in words will prevail. If the bidder does not accept the correction of the errors, its bid will be rejected.
- 17.3 The Purchaser may waive any minor informality or non-conformity or irregularity in a bid, which does not constitute a material deviation, provided such a waiver does not prejudice or affect the relative ranking of any bidder.
- 17.4 If a bid is not substantially responsive, it will be rejected by the Purchaser and may not subsequently be made responsive by the bidder by correction of the non-conformity.

18. EVALUATION AND COMPARISON OF BIDS

- 18.1 The purchaser's evaluation of a bid will take into account, basic price, excise duty, taxes, cost of inland transportation, insurance and all other costs incidental to the delivery, installation and commissioning at Rajiv Gandhi Govt. General Hospital, Chennai.
- 18.2 Comprehensive Annual Maintenance Contract (CAMC)

The comprehensive Annual Maintenance charges has to be quoted for a period of 5 years after the expiry of free maintenance period of 1 year, clearly indicating year wise comprehensive maintenance charges, as per Section XI.

19. CONTACTING THE PURCHASER

19.1 Any effort by a bidder to influence the purchaser in its decisions on bid evaluation, bid comparison, or selection may result in the rejection of the bidders bid. However, if the bidder wishes to bring additional information to the notice of the purchaser it should do so in writing.

F. AWARD OF CONTRACT

20. POST QUALIFICATION

20.1 The Purchaser shall determine to its satisfaction, whether the lowest bid and meets the all criteria specified in the tender and is qualified to perform the contract satisfactorily

- 20.2 The determination shall take into account the bidders financial, technical and production capabilities as well as such other information as the Purchaser deems necessary and appropriate.
- 20.3 An affirmative determination will be a prerequisite for award of the contract to the bidder. A negative determination will result in rejection of the bid, in which event, the Purchaser will proceed to the next lowest evaluated bid to make a similar determination.

21. AWARD CRITERIA

21.1 Purchaser will award the contract to the successful bidder whose bid has been determined to be substantially responsive and has been determined as the lowest evaluated bid.

22. PURCHASER'S RIGHT TO VARY QUANTITIES AT TIME OF AWARD

- 22.1 The Purchaser reserves the right at the time of award of contract to increase or decrease the quantity of goods and services originally specified in the bid document without any change in unit price or other terms and conditions with in the bid validity period.
- 22.1 The **quantity mentioned herein are approximate present requirement** and in case more or less quantity is required, the supplier should be prepared to effect supply at short notice on the same terms and conditions.

23. PURCHASER'S RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS

23.1 The Purchaser reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to award of Contract, without thereby incurring any liability to the affected bidder or bidders.

24. NOTIFICATION OF AWARD

- 24.1 Prior to the expiration of the period of bid validity, the Purchaser will notify the successful bidder in writing by a letter or by cable that its bid had been accepted, which will be confirmed by the bidder.
- 24.2 The notification of award will constitute the formation of the contract

25. DELAYS IN DELIVERY OF GOODS

- 25.1 Delivery of the Goods shall be made by the Supplier within 20 days from the date of placing the Purchase Order. If at any time during performance of the Contract, the Supplier should encounter conditions impeding timely delivery of the Goods, the Supplier shall promptly notify the Purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the Supplier's notice, the Purchaser shall evaluate the situation and may at its discretion extend the Supplier's time for performance, with or without penalty.
- 25.2 A delay by the Supplier in the performance of its delivery obligations shall render

the Supplier liable to the imposition of penalty subject to terms specified in the tender and purchase order, unless an extension of time is agreed upon pursuant to agreement without the application of liquidated damages.

25.3 If the Supplier fails to deliver any or all of the Goods or perform the Services within the time period(s) specified in the Purchase Order, the purchaser shall, without prejudice to its other remedies under the Contract, deduct from the Contract Price, as penalty, a sum equivalent to the percentage specified in the purchase order.

26 PAYMENT TERMS

26.1 Supply Part

- a) 70% within 30days on documentary proof of invoiced items on Pro-Rata basis, Goods Receipt Certificate at respective Hospital at Chennai, Tamilnadu.
- b) 20% after Testing, Commissioning and Handing Over of the item and Warranty Certificates.
- c) 10% after Testing, Commissioning and Handing Over of the complete system against Performance Bank Guarantee for equal value from a nationalized bank valid for a period of ONE year.
- d) The scope of supply, installation & commissioning of DG set involves related minor electrical & civil works. The quantity mentioned in the price schedule is the minimum required quantity, however the payment shall be made for the actual quantities, approved & certified by our HLL Engineer at site.
- e) Payment shall be made promptly by the Purchaser but in no case later than sixty (60) days after submission of the invoice/claim by the Supplier.
- f) Payment shall be made in Indian Rupees
- g) No advance payment is payable.

26.2 Service Part (as Applicable)

- 1) 100% after Testing, Commissioning and Handing Over of the complete system at the Hospitals against Performance Bank Guarantee valid for a period of ONE year.
- 2) Test Reports (as applicable) are to be forwarded along with the original invoices.
- 3) Payment for Annual Comprehensive Maintenance Contract Charges:
- 4) The payment of CAMC will be made on six monthly basis after satisfactory completion of said period, duly certified by the consignee. No advance payment is payable.

27. TAXES AND DUTIES

27.1 Suppliers shall be entirely responsible for all taxes, duties, license fees, octroi etc., incurred until delivery and handing over of the contracted Goods to the Purchaser.

SECTION III GENERAL CONDITIONS OF CONTRACT

1. DEFINITIONS

- 1.1 In this contract the following terms shall be interpreted as indicated:
 - (a) "The Contract" means the agreement entered into between the Purchaser and the Supplier as recorded in the Contract Form signed by the parties, including all the attachments and appendices thereto and all documents incorporated by reference therein;
 - (b) "The Contract Price" means the price payable to the Supplier under the Contract for the full and proper performance of its contractual obligations;
 - (c) "The Goods" means all the products, equipment, machinery, and/or other materials which the Supplier is required to supply to the Purchaser under the Contract;
 - (d) "Services" means services ancillary to the supply of the Goods, such as transportation and insurance, and other incidental services, such as installation, commissioning, provision of technical assistance, training and other obligations of the Supplier covered under the contract;
 - (e) "GCC" means the General Conditions of Contract contained in this section.
 - (f) "SCC" means the Special Conditions of Contract.
 - (g) "The Purchaser" means the Organization purchasing the Goods.
 - (h) "The Supplier" means the individual or firm supplying the Goods under this Contract;
 - (i) "Day" means calendar day.
 - (j) "Delivery period" means the period applicable upto completion of supply; installation and testing by the supplier at the required location mentioned in purchase order and accepted by the Purchaser.
 - (k) "Earnest Money Deposit" (EMD) means Bid Security / monetary or financial guarantee to be furnished by a tenderer along with its tender.

2. APPLICATION

2.1 These General Conditions shall apply to the extent that they are not superseded by provisions in other parts of the Contract.

3. STANDARDS

3.1 The Goods supplied under this Contract shall conform to the standards mentioned in the Technical Specifications.

4. PATENT RIGHTS

4.1 The Supplier shall indemnify the Purchaser against all third-party claims of infringement of patent, trademark or industrial design rights arising from use of the Goods or any part thereof in India.

5. INSPECTION AND TESTS

- 5.1 The Purchaser or its representative shall have the right to inspect and/or to test the Goods to confirm their conformity to the Contract at no extra cost of the Purchaser. The Purchaser shall notify the Supplier in writing of such inspection/test.
- 5.2 The inspections and test may be conducted on the premises of the Supplier or its subcontractor(s), at point of delivery and/or at the Goods final destination. The Supplier or its subcontractor(s), shall extend all reasonable facilities and assistance at no charge to the Purchaser.
- 5.3 Should any inspected or tested Goods fail to conform to the specifications, the Purchaser may reject them and the Supplier shall either replace the rejected Goods or make all alternations necessary to meet specification requirements free of cost to the Purchaser.

6. PACKING AND TRANSPORTATION

7 DELIVERY AND DOCUMENTS

8. INCIDENTAL SERVICES

- 8.1 The supplier may be required to provide any or all of the following services, including additional services, if any specified in the tender;
 - (a) Performance or supervision of the on-site assembly and/or start-up of the supplied goods
 - (b) Furnishing of tools required for assembly and/or maintenance of the supplied Goods;

10. WARRANTY

- 10.1 The Supplier shall warrant that the Goods supplied under this Contract are new and not having any defect arising from design, materials or workmanship.
- 10.2 This warranty shall remain valid for **one year** after the Goods or any portion thereof as the case may be, have been delivered to and finally accepted at the destination
- 10.3 The Purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 10.4 Upon receipt of such notice, the Supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective Goods or parts thereof, without cost to the Purchaser
- 10.5 If the Supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC within a reasonable period, the Purchaser may proceed to take such remedial action as may be necessary, at the Supplier's risk and expense and without prejudice to any other rights which the Purchaser may have against the Supplier under the contract.
- 10.6 Successful tenderer have to furnish security deposit/Performance Bank Guaranteee for 10% of Order value/contract value.

11. FIXED PRICES

11.1 Prices charged by the Supplier for Goods delivered and Services performed under the Contract shall not vary from the prices agreed by the Supplier and the Purchaser in release of initial Purchase Order.

12. CHANGE ORDERS

- 12.1 The Purchaser may at any time by written order given to the Supplier, make changes within the general scope of the Contract.
- 12.2 If any such changes cause an increase or decrease in the cost of, or the time required for, the Supplier's performance of any provisions under the Contract, an equitable adjustment shall be made in the Contract Price or delivery schedule, or both, and the Contract shall

accordingly be amended. Any claims by the Supplier for adjustment under this clause must be asserted within thirty (30) days from the date of the Supplier's receipt of the Purchaser's change order.

13. ASSIGNMENT

13.1 The Supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the Purchaser's prior written consent.

14. SUBCONTRACTS

- 14.1 The supplier shall notify the Purchaser in writing of all subcontracts awarded under the contract if not already specified in his bid. Such notification, in his original bid or later, shall not relieve the Supplier from any liability or obligation under the contract.
- 14.2 Sub-contract shall be only for bought-out items and sub-assemblies.

15. LIQUIDATED DAMAGES

15.1 If the Supplier fails to deliver any or all of the Goods or to perform the Services within the period(s) specified in the Contract, the Purchaser shall, without prejudice to its other remedies under the Contract, deduct from the Contract Price, as liquidated damages, a sum equivalent to the 0.5 percentage of the delivered price of the delayed Goods or unperformed Services for each week of delay or part thereof until actual delivery or performance, up to a maximum deduction of 10 percent of the delayed Goods or Services contract price. Once the maximum is reached, the Purchaser may consider termination of the Contract.

16. TERMINATION BY DEFAULT

16.1 The Purchaser may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, terminate the Contract in whole or part;

(a)if the Supplier fails to deliver any or all of the goods within the time period(s) specified in the Contract, or within any extension thereof granted by the Purchaser, or

- (b) if the Supplier fails to perform any other obligation(s) under the contract.
- 16.2 In the event the Purchaser terminates the Contract in whole or in part, the Purchaser may procure, upon such terms and in such manner as it deems appropriate, Goods or Services similar to those undelivered, and the Supplier shall be liable to the Purchaser for any excess costs for such similar Goods.

17. FORCE MAJEURE

- 17.1 For purposes of this Clause "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 17.2 If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such conditions and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

18. TERMINATION FOR INSOLVENCY

18.1 The Purchaser may at any time terminate the Contract by giving written notice to the Supplier, if the Supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the Supplier, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the Purchaser.

19. RESOLUTION OF DISPUTES

- 19.1 The Purchaser and the supplier shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract.
- 19.2 If, after thirty (30) days from the commencement of such informal negotiations, the Purchaser and the Supplier have been unable to resolve amicably a Contract dispute, such dispute or difference shall be settled in accordance with the Arbitration and Conciliation Act 1996 the Arbitral Tribunal shall consist of 3 Arbitrator, one each to be nominated by the Purchaser and the supplier. The third Arbitrator shall be chosen by the two Arbitrators so appointed by the parties and shall act as Presiding Arbitrator.
- 19.3 In case of failure of the two Arbitrator appointed by the parties to reach upon a consensus within a period of 30 days from the appointment of the Arbitrator appointed subsequently, the Presiding Arbitrator shall be appointed by the President of Institute of Engineers (India).
- 19.4 The venue of arbitration shall be the place from where the Contract is issued i.e. Thiruvananthapuram.

20. APPLICABLE LAW

20.1 The Contract shall be interpreted in accordance with the laws of the Union of India.

21. NOTICES

- 21.1 Any notice given by one party to the other pursuant to this Contract shall be sent to other party in writing or by cable and confirmed in writing to the other Party's address specified in Special Conditions of Contract.
- 21.2 A notice shall be effective when delivered or on the notice's effective date, whichever is later.
- 21.3 The jurisdiction of any disputes, suits and proceeding arising out of the tender shall be only in the court of Thiruvananthapuram
