The mother cuboid / pallet is to be arranged at HLL warehouse at Delhi /Gurgaon after opening and documentary evaluation of technical bid. The mother cuboids is to be arranged within 7 days from the intimation from HLL
- 1.4. Bidder should able to submit 432 Trays as per the specification and drawing for demonstration during the EOI evaluation stage which shall form a part of selection process for the empanelment. The tray is to be arranged at HLL warehouse at Delhi /Gurgaon after opening and documentary evaluation of technical bid. The tray is to be arranged within 7 days from the intimation from HLL
- 1.5. HLL shall return the unutilized / untested samples submitted by the bidder after completion of the technical evaluation and empanelment of the supplier in as-is- where-is condition from HLL Delhi / Gurgaon warehouse within 7 days from the date of receipt of request from the bidder for the same. Request(s) which are received within 30 days from the date of empanelment shall only be considered for the return of the sample.
