- 6. The items should be delivered and installed within 2 (Two)weeks from the date of issue of Purchase Order.
- 7. Penalty at 0.50 % of the total Purchase Order valuefor each week of delay or part thereofsubject to a maximum of 5 % is applicable for delayed delivery.
- 8. The bid shall be evaluated by taking the total amount quoted for all the items.
- 9. Necessary user manuals/CDs/DVDs/accessories/License documents are to be supplied along with the items.
- 10. The minimum warranty period (onsite) of theitemsis 3(Three) Yearsfrom the date of installation. All defective HDDs should be replaced at free of cost and the break down calls of all the items should be attended by the Supplier during the warranty period.
- 11. Installation of SAS HDDs and successful configuration/integration of the same with existing IBM V5000 Storage are purely under the scope of the bidder only with the necessary support from M/s IBM if required.
- 12. Bids should be clear in all respects and those with ambiguous and conditional clauses shall be rejected.
