The qualification criteria should be liberal enough so that equal opportunity for all bidders should there, which results in more participation and ultimately better pricing to the Ex-Chequer. Hence we request to please <u>Delete Average Net Worth Method</u> and insted of this Solvency Certificate should be asked as it was done in SIX AIIMS MOT Tender.
