

CORRIGENDUM-III

1. *The existing "per kit quantities for Maldives mentioned in Annexure-I of Corrigendum - I for Kit A2" is deleted.*
2. *In Section - IX under PROFORMA-A on page no: 69 "the PROFORMA-B" is added as Annexure-III.*
3. *Part-A and Part-B as mentioned under Clause "C" in Section-IX may be read as PROFORMA-A and PROFORMA-B respectively.*
4. *Under Section-IX, clause "D", the word "two brands" may be read as "three brands". In addition to the Corrigendum-I issued under this clause following is also added:*

"Manufacturers Authorization as per format in Section-XIV is required only for the equipment(s) and not for consumables".

5. *Under GIT clause: 33.2, following is deleted:*

"However, in case of Indian bidder, the Purchaser reserves the right to award the contract in Indian Rupees, by converting the quoted US Dollars at the SBI TT Selling Exchange Rate, as prevailing on the date of opening of techno commercial bids. In such case, no foreign exchange variation shall be admissible or payable to Indian supplier, during entire execution of contract".

6. *Under GCC clause 21.6, existing entries "However, Purchaser reserves the right to make payments directly, or through SAARC Development Fund (SDF), in which case, supplier shall be informed well in time" may be read as "The payment shall however be made by SAARC Development Fund (SDF) directly to the supplier in US\$".*
