**ELIGIBILITY CRITERIA**

**Tenderer/Party should submit the vehicle ownership documents (Registration certificates) before collecting the work order from HLL.**

**In case, failure to submit the ownership document within one month of intimation, EMD will be forfeited.**

❖ **WATER SUPPLY THROUGH TANKER (SUMMER SEASON)**

1. Party shall quote rate for summer season supply (February to July)
2. Party shall supply clean potable water on daily basis consistently.
3. Quantity of water to be supplied by party will be decided by HLL.
4. Quantity of water to be supplied by party may change time to time as per HLL requirement.
5. Party shall make his own arrangements of water and power resources to ensure consistency in water supply.
6. Party shall take all necessary precautions to ensure safe supply of water on regular basis.
7. **Contract period will be during February to July of each year of 2017 & 2018.**
8. **HLL has right to vary the period depend upon availability of water/rain etc.**
9. Procuring and supply of water is the sole responsibility of the contractor.
10. The supplied water will be tested in our laboratory for ph, suspended solids etc. (allowable value ph 6.25 and suspended solids 5 mg/l)

11. If the contractor fails to supply the water as per our requirement penalty will be imposed. The amount to be paid as penalty will be the actual amount that we are going to incur in bringing the water to our site on our own + additional amount of 10% of the actual expensed incurred.
12. If the supplier fails to supply the water, the same will be treated as non-performance and resulting in forfeiture of security deposit. The same will be at the discretion of the management and the matter cannot be referred to court.
13. The supplier has to deposit an amount of Rs. 15,000/- as Security Deposit (in case of placement of order) and the same will be returned after the expiry of the contract.
14. No advance will be given against the said contract.
