3. In case the date mentioned above is declared subsequently as holiday for the Company's office, the due date for submission and opening of bids will be the next working day at the same venue and time. Bids received after the last date and time for submission shall not be considered.
4. The Bidder is expected to examine all work requirements, Instructions, Forms, Terms and Conditions given in the bidding documents. Failure to furnish all information required in the Bidding documents or submission of a Bid not subsequently responsive to the bidding documents in every respect will be at the Bidders risk and may result in rejection of the Bid

OTHER TERMS & CONDITIONS

- **PRICES:** Prices quoted should be “Firm & Final’ inclusive of all levies, Taxes & Duties. Overwriting should be avoided in the Price – Bid / Quotation.
- **INSPECTION:** HLL reserves the right to inspect & Test the quality & standards of the stores for assessment of quality before dispatch to the consignee or at the consignee end,.
- **PAYMENT TERMS:** HLL payment terms will be as below.
“ PAYMENT WILL BE RELEASED WITHIN 30 DAYS FROM COMPLETION OF THE WORK”
- **LIQUIDATED DAMAGES:** In the event of placement of order, the contractor fails to complete the work as per the schedule given / agreed, HLL reserves the right to levy liquidated damages @ 0.5% of the total work order value per week delay, subject to maximum of 10% . Once the maximum is reached HLL will be at liberty to terminate the contact and to get the work done from alternate source at the cost & risk of the contractor.
- **SECURITY DEPOSIT (SD):** SD @ 5 % of order Value will be recovered & retained for one year from the date of completion of the work. OR the supplier has to submit a Bank Guarantee valid for one year for equivalent amount.
- **VALIDITY:** The offer should be valid for minimum 90 days from the date of opening.
- Electricity for minor works, which are to be carried out on the site, will be made available at FREE OF COST.
- Supplier / Contractor should supply the goods as per the Tender Specifications. Any Deviations in the quality are not acceptable.
- **ACCIDENT & INSURANCE:** In case of any accident to the labours engaged by the contractor while executing the work, contractor shall be responsible for the same and shall pay the compensation as per WCA & rates framed there under. The contractor shall arrange necessary insurance for the workmen.
