## ANNEXURE VI

Bidder should submit self-attested photocopies with bidder's Office Seal of tax payments, insurance payments, non-pollution certificates and RC Books of all their vehicles at the time of Technical Bid Opening.

Bidder should submit self-attested photocopies with bidder's Office Seal on Service Tax Registration, PAN Card and other statutory and non-statutory requirements. The tenderer should be registered with Central Excise Department for providing vehicle hire service.

The rates quoted shall include wages to the driver, cost of the fuel, maintenance charges, service tax and other charges if any for providing the vehicle in good running condition. In case of any accident or maintenance of the vehicle provided by the bidder, the same shall be attended by the bidder at own cost and responsibility and shall attend the same without any liability to HLL Lifecare Limited. In case, the vehicle entrusted cannot be made available due to breakdown, Inspection for any other reason whatsoever, the bidder shall make alternative necessary arrangements to provide substitute vehicle.

The bidder should also ensure that minimum wages is paid to the driver provided to HLL Lifecare Ltd. and a certificate to this effect shall be rendered by the bidder along with the monthly bill.

The drivers and vehicles should be covered by valid Insurance and the Payment of compensation in case of any accident or otherwise shall be the responsibility of the bidder.

If the services of the successful bidder are not satisfactory, HLL Lifecare Limited reserves the right to cancel the contract. Any loss or difficulty or inconvenience to the company with regard to this contract due to the lapse from the successful bidder, the loss or inconvenience shall be the risk of the Successful bidder and the amount shall be deducted from the Security Deposit. The successful bidder shall furnish a Security deposit in the form of a Demand Draft from a scheduled bank drawn in favour of **HLL Lifecare Limited, payable at Cochin** or a Bank Guarantee from a scheduled bank, for an amount equal to 5% i.e Rs 60,000/- of the total price on the value of the contract as Security Deposit for his faithful execution of the contract.

## **ANNEXURE-VI**

The meter indicating the kilometer should be accurate and in working condition as per the regulation of the Regional Transport Authorities concerned. The kilometer reading will be counted at the factory premises for starting and closing and no mileage will be allowed for any lunch or tea break of drivers.

A Log book/Sheet will be kept in Vehicles under the custody of the driver for verification with Company records in this regard.

The driver shall fill in the Trip Sheet forms made available from the Security Gate of HLL Lifecare Ltd..

The contract will normally be for a period of one year. The successful bidder shall provide the vehicles based on the requirement of the company.

On awarding the contract, the successful bidder shall execute an agreement with HLL Lifecare Limited in the format prescribed by HLL on stamp paper of Rs.100/- (Rupees Hundred only). The draft Agreement available with HR Department shall be examined and fully understood by the bidders before filling the tender.

The drivers of the vehicle and the vehicle shall satisfy all statutory requirements applicable from time to time. Any laxity in the behaviour of the driver shall be treated as breach of contract resulting in cancellation of contract. The driver should wear uniform prescribed by the Company and shall be well behaved.

The vehicles hired shall be provided by the successful bidder within 15 to 30 minutes after receiving the intimation. HLL Lifecare Limited reserves the right to increase or decrease the number of vehicles to be hired.

The payment will be on a monthly basis within 15 days, after the verification of the received invoices.

The vehicles shall be provided for all the days including holidays.

Being a CSEZ unit we are exempted from all types of taxes and levies. Necessary documents will be issued on the receipt of the invoices.

The company management has the right to cancel this tender or to award the contract to one party or to more than one party fully or partially at its discretion. The decision of the Factory Unit Chief – HLL KFC on the matter shall be final and binding on all tenderers.
