TERMS AND CONDITIONS:-

1. The areas for the treatment can be inspected on all working days between 08.00 A.M to 6.00 P.M. Details of Locations is attached (Annexure 1)*
2. The tenderers should be experienced and licensed in providing Pest Control Services
3. The party should provide the detailed description of the material, trade name/chemical name, method of application of the material and concentration of the material dosage quantity during application.
4. The party should furnish the **material safety data sheet (MSDS)** of the material which includes
 - a) Safety precautions during handling.
 - b) Antidote treatment which includes the first aid measures, drug therapy, applicable warranty, caution steps.
 - c) Method of handling the materials and its effect on inhalation, skin and oral toxicity.
 - d) Storage conditions applicable and the package details.
5. The party should furnish **environmental clearance certificate (ECC)** of each of the materials used to demonstrate that the materials are not hazardous to Environment.
6. The pesticides having **ISI mark** only will be used for the treatment.
7. The Contractor will be fully responsible for the supervision and control of the Treatments.

9. The Received quotations will be opened at 14.30 Hrs. on 05/02/2021 in the presence of Company Representatives. Interested Tenderers also can be present at the time of opening.
10. The Contractor at own cost will bring all materials required for the treatments.
11. Since Project is in implementation phase and new centers are adding gradually in next few months. Therefore work order maybe placed in staggered mode based on the existing operational centers.
12. Total area of entire premises per location is approx. 800 square feet, therefore treatment/disinfestation will cover that whole area.
13. Payment Terms – Quarterly payment will be released within 30 days of receipt of invoices of disinfestations along with the work completion report, the rates are inclusive of tax. (Invoices along with the work completion report duly signed by HLL representative of the respective centers shall be raised on a quarterly basis.) Payment of all one time activities like Rodent control machines & Termite treatment will be made 90% within 30 days of submission of centre representative verified invoices and 10% post completion of tender tenure. The statutory deductions such as ESI, PF etc as applicable, are to be paid by the Contractor.
14. The area to be treated may vary depending on the locations. Hence rate should be quoted separately for each location.
15. On awarding the contract, an agreement has to be executed in Stamp paper of Rs.200/- (Rupees Two Hundred only).
16. The successful bidder shall deposit 5% of the total work order value towards Security Deposit.
17. Retention period of Security deposit: 6 months post completion of tender tenure.
