6. **“Bid Validity”** shall mean the period for which the Bids shall remain valid.
7. **“Bidder”** shall mean the party participating in the Tendering process pursuant to and in accordance with the terms of this document.
8. **“Contract Agreement”** shall mean the agreement to be signed between the Successful Tenderer and the competent authority of HITES.

NOTICE INVITING TENDER

3. Agreement shall be drawn with the successful tenderer and all the volumes of the tender document shall form part of the contract.
4. The time allowed for carrying out the work will be 12 months from the date of letter of acceptance or from the first day of handing over the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
5. The site for the work is available.

9. Tender document shall be submitted on or before the due date of submission of tender. The Technical Bid will be opened by the authorized representative at the office of the Associate Vice President (ID) & Head ROT, HLL Infra Tech Services Limited, Golden Jubilee block, HLL Bhavan, Poojappura P.O, Thiruvananthapuram- 695 012 .
10. The contractor shall be required to deposit an amount equal to 5% of the tendered value of the work as performance guarantee in the form of an irrevocable guarantee bond of any scheduled bank or State Bank of India in the prescribed form within 30 days of issue of letter of acceptance.
11. The scope of the work is Construction of Building Phase II at CAPT, Thiruvananthapuram.
12. Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity, access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender implies that the tenderer has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done, local conditions and other factors having a bearing on the execution of the work.
13. HITES/CAPT does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without assigning any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer, shall be summarily rejected.
14. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
15. HITES/CAPT reserves the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rates quoted.

The firm or contractor shall not be permitted to tender for work in case his near relative (s) (directly recruited or on deputation in HITES) is/are posted in any capacity either non-executive or executive employee. The contractor shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who

are near relative to any executive employee/ gazetted officer in .HITES or in the Ministry of Health and Family Welfare.

16. No Engineer of Gazetted rank or other Gazetted Officer employed in engineering or administrative duties in an Engineering Department of the Government of India/State Government or PSE's is allowed to work as a contractor for a period of two years after his retirement from Govt. service, without previous permission of the Govt. of India or HLL in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Govt. of India/State Government or PSE's as aforesaid before submission of the tender or engagement in the contractor's service.
17. The tender for the work shall remain open for acceptance for a period of 120 days from the date of opening of financial bid. If any tenderer withdraws his tender before the said period or issue of letter of acceptance/intent, whichever is earlier, or, makes any modifications in the terms and conditions of the tender which are not acceptable to the HITES, then the HITES shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid.
18. This Notice Inviting Tender shall form a part of the Contract Document. In accordance with clause 1 of the contract, the letter of acceptance shall be issued in favour of the successful Tenderer/Contractor. The contract shall be deemed to have come into effect on issue of communication of acceptance of the tender. On such communication of acceptance, the successful Tenderer/Contractor shall, within 30 days from such date, formally sign the agreement consisting of: -

The Notice Inviting Tender, all the documents including additional conditions, specifications and drawings, forming part of the tender, and, as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto. SECTION II

INFORMATION & INSTRUCTIONS FOR APPLICANTS

1.0 GENERAL:

- 1.1 Letter of transmittal and forms for Technical Evaluation are given in Section III.
- 1.2 All information called for in the enclosed forms should be furnished against the relevant columns in the forms. If for any reason, information is furnished on a separate sheet, this fact should be mentioned against the relevant column. Even if no information is to be provided in a column, a “nil” or “no such case” entry should be made in that column. If any particulars/query is not applicable in case of the applicant, it should be stated as “not applicable”. The applicants are cautioned that not giving complete information called for in the application forms or not giving it in clear terms or making any change in the prescribed forms or deliberately suppressing the information may result in the applicant being summarily disqualified. Applications made by telegram or telex and those received late will not be entertained.
- 1.3 The application should be neatly type-written in English.
- 1.4 Overwriting should be avoided. Correction, if any, should be made by neatly crossing out, initialing, dating and rewriting. Pages of the qualification document are numbered. Additional sheets, if any added by the contractor, should also be numbered by him. They should be submitted as a package with signed letter of transmittal.
- 1.5 References, information and certificates from the respective clients certifying suitability, technical know how or capability of the applicant should be signed by an officer not below the rank of Executive Engineer or equivalent.
- 1.6 The applicant may furnish any additional information, which he thinks is necessary to establish his capabilities to successfully complete the envisaged work. He is, however, advised not to furnish superfluous information. No information shall be entertained after submission of tender document unless it is called for by the Employer/ HITES.
- 1.7 Any information furnished by the applicant found to be incorrect either immediately or at a later date, would render him liable to be debarred from tendering/taking up of work for HLL Infra Tech Services Limited.

- 1.8 Prospective applicants may request clarification regarding the Tender document on before the date specified in the “**SCHEDULE FOR SUBMISSION OF APPLICATION**”. Any clarification given by the Employer will be posted in the web sites of HLL/HITES. No request for clarification will be considered after.
- 1.9 Joint Venture firms are not allowed to participate in the tender.

2.0 METHOD OF APPLICATION:

- 2.1 If the applicant is an individual, the applicant shall affix his signature above his name type written in full along with his current address.
- 2.2 If the applicant is a proprietary firm, the application shall be signed by the proprietor above his name type written in full along with the full name of his firm and its current address.
- 2.3 If the applicant is a firm in partnership, the application shall be signed by all the partners of the firm above their full type-written names and current addresses or alternatively by a partner holding power of attorney for the firm. In the latter case a certified copy of the power of attorney should accompany the application. In both cases a certified copy of the partnership deed and current address of all the partners of the firm should accompany the application.
- 2.4 If the applicant is a limited company or a corporation, the application shall be signed by a duly authorized person holding power of attorney for signing the application accompanied by a copy of the power of attorney. The applicant should also furnish a copy of the Memorandum of Articles of Association duly attested by a Public Notary.

3.0 FINAL DECISION MAKING AUTHORITY

The employer/HITES reserves the right to accept or reject any application and to annul the qualification process and reject all application at any time, without assigning any reason or incurring any liability to the applicants.

4.0 PARTICULARS PROVISIONAL

The particulars of the work given in Section 1 are provisional. They are liable to change and must be considered only as advance information to assist the applicant.

5.0 SITE VISIT

The applicant is advised to visit the site of work, at his own cost, and examine it and its surroundings by himself, collect all information that he considers necessary for proper assessment of the prospective assignment.

6.0 TENDER DOCUMENTS

6.1 The tender documents consisting of the following two parts

1. **Part-1** - Technical Bid - Part-I
2. Part-II – General Conditions of Contract
3. **Part-2** - Price Bid

6.2 The tenderer is expected to examine carefully all the contents of the tender documents including instructions, conditions, forms, terms etc. and take them fully into account before submitting the offer. Failure to comply with the requirements as detailed in these documents shall be at the tenderers own risk.

7.0 SUBMISSION OF THE TENDER DOCUMENTS

The tender document shall be submitted in two parts

1. 1. Part- 1- Technical Bid (Technical Bid Part-I, General Conditions of Contract-Part-II)
2. Part- 2 -Price Bid

6.1 Part –I Technical Bid shall consisting of the following,

- a. Earnest Money Deposit
Earnest Money Deposit, as detailed in clause 6 of NIT in original, placed in a separate sealed envelope and duly marked “Earnest Money Deposit”.
- b. Power of Attorney
Attested copy of Power of Attorney (in favour of the authorized signatory of the tenderer) to submit the tender.
- c. Signed copies of Technical Bid, General Conditions of Contract & Drawings.
- d. Letter of transmittal
The applicant should submit the letter of transmittal attached with this document.
- e. Financial information
Applicant should furnish the Annual financial statement for the last three years (in Form “A”).

f. Experience in works / similar works

Applicant should furnish the following:

- A. List of all works of similar class successfully completed during the last three years (in Form "B").
 - B. List of the projects under execution or awarded (in Form "C").
 - C. Particulars of completed works and performance of the applicant duly authenticated/certified by an officer not below the rank of Executive Engineer or equivalent should be furnished separately for each work completed or in progress (generally as in Form "D").
- g. Organization information

Applicant is required to submit the following information in respect of his organization (in Forms "E").

- A. Name & Postal Address, Telephone & Fax Number etc.
- B. Copies of original documents defining the legal status, place or Registration and principal places of business.
- C. Valid VAT/Works Contract Tax registration with Sales Tax Department.
- D. Names & Title of Directors and Officers to be concerned with the work, with designation of individuals authorized to act for the organization.
- E. Information on any litigation in which the applicant was involved during the last five years, including any current litigation.
- F. Authorization for employer to seek detailed references.
- G. Details & Expertise of the Applicants

6.2 Part -II Price Bid shall consisting of the following

- a. Completed price Bid

8.0 ELIGIBILITY CRITERIA FOR QUALIFICATION

I. FOR ENLISTED CONTRACTORS WITH HITES

- a) They should have been declared or enlisted in Class H (CW) or above of any one of the categories from I ,III & IV.
- b) For category IV, the applicant shall produce the credentials of the subcontractor /agency doing electrical works. The electrical subcontractor should have valid contractor's /Supervisory license as per the rules and regulations of Kerala State Electrical Licensing Authority, for similar works. Suitable competent electrical subcontractor should engage full time Engineer/ Supervisor for the work.
- c) Those who had done work/doing work in CAPT/HITES/HLL shall produce completion/progress certificate from the Engineer in charge not below the rank of Project manager that the work is satisfactory. This is mandatory
- d) The applicant should have sufficient number of Technical and Administrative employees as per clause 36(i) of General Conditions of contract for the proper execution of the contract. The applicant should submit a list of these employees stating clearly how they would be involved in this work

For enlisted parties, only the eligibility criteria are separate as above. They shall abide all other conditions in the tender including submission of EMD and tender cost.

II. FOR NON-ENLISTED CONTRACTORS WHO ARE INTERESTED TO PARTICIPATE

- a) The applicant should have an establishment in Kerala.
- b) The applicant should be a registered contractor of Central/State Government OR Central/State Autonomous Body OR Central/State PSUs or a standing contractor of HLL Infra Tech Services Limited.
- c) Those who had done work/doing work in CAPT/HITES/HLL shall produce completion/progress certificate from the Engineer in charge not below the rank of Project manager that the work is satisfactory. This is mandatory
- d) The applicant shall produce the credentials of the subcontractor /agency doing electrical works. The subcontractor should have valid contractors /Supervisory license as per the rules and regulations of Kerala State Electrical Licensing Authority, for similar works. Suitable competent electrical subcontractor should engage full time Engineer/ Supervisor for the work.

e) The applicant shall have the eligibility criteria and experience as follows.

The applicant should have satisfactorily completed during the last seven years ending last day of the month of June 2018.

1. Three similar works each costing not less than 40% of the estimate value or
2. Two similar works each costing not less than 60% of the estimate value or
3. One similar work each costing not less than 80% of the estimate value

Similar Works” shall mean a Project comprising Construction of RCC framed structure including finishing works .

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to the last date of receipt of applications for tender.

The applicant should submit successful completion certificates for the above works. The certificate issued by Client should contain date of start, date of completion, value on completion etc.

f) The applicant should have had an average annual financial turn over (gross) of Rs 85.80 Lakhs on Civil construction works during the last three consecutive financial years ending 31st March 2017. The figures shall be supported with copies of relevant pages in Balance sheet duly certified by Chartered Accountant.

g) The applicant should not have incurred any loss in more than two years during the immediate last five consecutive financial years ending 31st March 2017. The figures shall be supported with copies of relevant pages in Profit & Loss account duly certified by Chartered Accountant

h) The applicant should own construction equipment as per list required for the proper and timely execution of the work. Else, he should certify that he would be able to manage the equipment by hiring etc., and submit the list of firms from whom he proposes to hire.

i) The bidder shall submit the copy of GST Registration or the acknowledgement copy as a proof of registration

j) The applicant should have sufficient number of Technical and Administrative employees as per clause 36(i) of General Conditions of contract for the proper execution

of the contract. The applicant should submit a list of these employees stating clearly how they would be involved in this work.

9.0 EVALUATION OF TECHNICAL BID

9.1 The applicants will be evaluated in the following manner:

- i. The initial criteria prescribed above in respect of experience of similar class of works completed, and financial turn over etc. will first be scrutinized and the applicant's eligibility for qualification for the work is determined.

HITES/CAPT, however, reserves the right to restrict the list of qualified bidders to any number deemed suitable by it.

- b. Even though an applicant may satisfy the above requirements, he would be liable for disqualification if he has:
 - A. Made misleading or false representation or deliberately suppressed the information in the forms, statements and enclosures required in the pre-qualification document,
 - B. Record of poor performance such as abandoning work, not properly completing the contract, or financial failures/ weaknesses etc.
 - C. If the applicant, or any constituent partner in case of partnership firm, has been debarred/black listed or terminated for poor performance by any organization at any time or ever been convicted by a court of law , their application will be summarily rejected.

9.2 All tenderers who qualified based on Technical Bid evaluation shall be informed and their price bids shall be opened on the date and time informed by HITES.

10. SIGNING OF THE APPLICATION AND NUMBER OF COPIES

10.1 The power of attorney on a stamp paper authorizing the person to sign and act on behalf of the firm, duly notarized should be submitted.

10.2 The completed tender shall be without alteration, overwriting, interlineations or erasures except those to accord with instructions issued by HITES or as necessary to correct errors made by the tenderer. All amendments/ corrections shall be initialled by the person/ persons signing the tender.

10.3 An authorized representative shall have the authority to conduct all Business and incur liabilities related thereto for and on behalf of the Applicant, during the process and thereafter.

11.0 SEALING AND MARKING OF APPLICATIONS

11.1 The Technical and Price bids shall be sealed in two separate envelopes, superscribed as PART-1 Technical bid and PART-2 Price Bid respectively. The two covers shall be sealed in a single large envelope and submitted on or before the last date and time for submission of the application. The envelopes shall be titled "Construction of Building Phase II at Kerala State Centre for Advanced Printing & Training "CAPT", Thiruvananthapuram." clearly marked in English with name of the Applicant.

11.2 No responsibility will be accepted by the HITES for the misplacement or premature opening of a tender, not sealed or marked as per aforesaid instructions.

12.0 DEADLINE AND ADDRESS FOR SUBMISSION OF APPLICATIONS

12.1 Applications shall be submitted to the below address before the due date and time of submission of tender. HITES shall not assume any responsibility for any delay in submission of tender. Documents submitted in connection with this tender will be treated confidential.

12.3 HITES may, at its discretion, extend the deadline for the submission of Tender, in which case all rights and obligations of HITES and the Applicants subject to the previous deadline shall thereafter be subject to the deadline as extended.

13 LATE APPLICATIONS

Application received after the dead line of submission of Application shall not be considered or opened under any circumstances.

14 VALIDITY OF TENDER

Tender document shall be valid for a period of 120 days from the date of opening of price bid. HITES retain the right that in exceptional circumstances at its own discretion, it may ask the applicants to extend the validity of their application for a specified period. The Applicant not submitting the letter of extension of the validity period at that time shall not be further considered.

15.0 AMENDMENT OF TENDER DOCUMENTS
