ELIGIBILITY CRITERIA

Tenderer/Party should submit the vehicle ownership documents (Registration certificates) before collecting the work order from HLL.

In case, failure to submit the ownership document within one month of intimation, EMD will be forfeited.

❖ SUPPLY OF WATER TANKER THROUGH TANKER (REGULAR & SUMMER SEASON)

1. Party shall supply clean potable water on daily basis consistently.
2. Quantity of water to be supplied by party will be decided by HLL.
3. Quantity of water to be supplied by party may change time to time as per HLL requirement.
4. Party shall make his own arrangements of water and power resources to ensure consistency in water supply.
5. Party shall take all necessary precautions to ensure safe supply of water on regular basis.
6. **Contract period one year from the date of work order.**
Summer Season: February to July
Regular: August to January
7. **HLL has right to vary the period depend upon availability of water / rain etc.**
8. Procuring and supply of water is the sole responsibility of the contractor.
9. The supplied water will be tested in our laboratory for ph, suspended solids etc (allowable value ph 6.25 and suspended solids 5 mg/l).

10. If the contractor fails to supply the water as per our requirement penalty will be imposed. The amount to be paid as penalty will be the actual amount that we are going to incur in bringing the water to our site on our own + additional amount of 10% of the actual expensed incurred.
11. If the supplier fails to supply the water, the same will be treated as non-performance and resulting in forfeiture of security deposit. The same will be at the discretion of the management and the matter cannot be referred to court.
12. The supplier has to deposit an amount of Rs. 15,000/- as security deposit (in case of placement of order) and the same will be returned after the expiry of the contract.
13. No advance will be given against the said contract.
14. HLL Lifecare will not give any compensation; in case of water is not required due to some unforeseen reason. Force majeure clause is applicable.
15. HLL Lifecare Ltd., reserves the right to cancel the contract without paying any compensation whatsoever on account of any alternate arrangements made to meet the requirement of water.
16. In case no reference is made to taxes it would be presumed that the taxes are not applicable and the commercial evaluation would be done accordingly.
17. No idling charges will be paid by the company.
18. In case of failure /breakdown of vehicles, the contractor has to make an alternative arrangement to avoid delay.
19. In case of agreement contract proof also should attach to show the source is having sufficient yield in the recent past.

20. Party shall submit Updated emission test certificate from appropriate authority from time to time upon expiry of old and driving licence should be produced whenever required.
21. Party shall submit valid vehicle fitness certificate before receiving the order and also submit new fitness certificate upon expiry of old fitness certificate. In case non-submission of the same HLL has right to cancel the contract & forfeit EMD/ security Deposit.
22. 20% of annual procurement value will be sourced from Micro and Small Enterprises (MSE), out of which 4% is earmarked for procurement from MSE's owned by SC or ST entrepreneurs. 24. EMD of Rs. 5,000/- (Rupees Five Thousand Only) should be submitted along with the quotation by way of demand draft drawn in favour of M/s. HLL Lifecare Limited, Kanagala payable at Nipani. Tenders without EMD will be liable for rejection.
