**TERMS AND CONDITIONS FOR HIRING OF VEHICLES FOR
OFFICIAL USE ON CONTRACT BASIS**

- 1) **The tenderer must be the owner of vehicles. The vehicle should be registered after January 2012. Copy of the RC book to be enclosed along with the tender to prove the ownership and year of Registration.**
- 2) **The bidder should not offer vehicles which are already under contract with other units of HLL or with any other organization.**
- 3) **An EMD of Rs.5,000/- (Rupees five thousand only) per vehicle by way of Demand Draft favouring HLL Lifecare Limited, Trivandrum payable Thiruvananthapuram should accompany the tender. Tender without EMD will be summarily rejected.**
- 4) **The rate should be quoted in the enclosed format.**
- 5) **An amount of Rs.10,000/- per vehicle is to be remitted as security deposit by the successful tenderer, for the vehicle.**
- 6) **The Earnest money of successful bidder/s will be converted to Security deposit and they will be required to remit only the balance amount. EMD remitted will be forfeited if the successful tenderer withdraws after opening the tender.**
- 7) **The Contractor shall provide the vehicle along with driver and keep the vehicle in good running condition.**
- 8) **The rates quoted shall include wages to the driver, cost of oil, fuel, taxes, insurance, service charges. The Contractor shall solely be responsible for compliance to statutory and non-statutory requirements involved in providing the vehicle on monthly rental.**
- 9) **In case of any accident the contractor would be solely liable and HLL will not have any liability for the damages or compensation.**
- 10) **The contractor shall bear the cost of all the maintenance work of the vehicle provided. In case, the vehicle cannot be made available due to breakdown, Inspection etc., the contractor shall make alternative arrangements to provide substitute vehicle of the same category.**

- 11) **The driver and vehicle should be covered by valid Insurance and the Payment of compensation in case of any accident or otherwise shall be the responsibility of the contractor.**
- 12) **No advance will be given for the service provided by the contractor and the payment will be made only on monthly basis on presentation of bill after statutory deductions such as Income Tax. The contractor should also ensure that minimum wages is paid to the driver and a certificate to this effect shall be submitted by the contractor along with the monthly bill.**
- 13) **If the services of the contractor are not satisfactory, HLL Lifecare Limited reserves the right to cancel the contract after giving 30 days notice.**
- 14) **In case the contractor fails to provide the vehicle on any day, the same will attract penalty and the additional expense incurred by the company in this regard for engaging vehicles from alternate sources will be deducted from the contractor bill / Security Deposit.**

Penalty will be as under :-

a. Indica/ Vista/Indigo - Rs.1000 / day

- 15) **Failure to supply vehicles continuously for a period of seven days will be treated as breach of contract and the Security deposit will be forfeited.**
- 16) **The meter indicating the kilometer should be accurate and in working condition as per the regulation of the Regional Transport Authorities concerned. The kilometer reading will be recorded at the factory premises and kilometer for to and fro running to garage shall be fixed at the negotiation meeting.**
- 17) **Log book will be kept in Vehicle under the custody of the driver for recording the distances of journeys performed and will be verified before the settlement of monthly bill.**

- 18) **The driver shall fill in the Trip Sheet forms made available from the Security Gate.**
- 19) **The contract will be for a period of three years. The contractor shall provide the vehicles based on the requirement of the company. Though the requirement normally is for 12 hours, the vehicle with driver has to be provided for extended hours as per requirement and the payment for additional km run will be calculated on a quarterly basis and the payment will be made for excess kms.**
- 20) **On awarding the contract, the contractor shall execute an agreement with HLL Lifecare Limited to the effect in a stamp paper equivalent to Rs.100/- (Rupees One Hundred Only). The draft Agreement available with HR Department shall be fully understood by the tenderers before filling the tender.**
- 21) **The drivers of the vehicle should be well behaved and hold valid driving license. The driver is required to wear uniform prescribed by the Company.**
- 22) **The additional vehicles hired shall be provided by the contractor within reasonable time after receiving the intimation. HLL Lifecare Limited reserves the right to increase or decrease the number of vehicles to be hired.**
- 23) **The vehicle with driver has to be available on all days. However the company may at its discretion can allow off on alternate Sundays which cannot be taken as a right.**
- 24) **In the event of any dispute the same shall be referred to the Unit Chief, Peroorkada Factory, Thiruvananthapuram. The decision of Unit Chief in the matter shall be final and binding on all the tenderers/ contractors.**
- 25) **The rate finalized against the tender shall remain firm and valid for a period of three years from the date of work order and no revision/escalation will be considered except in the case of increase or decline in fuel price.**
