D. SUBMISSION OF TENDERS

22. Submission of Tenders

22.1

(i) Pre-qualification and Technical compliance as per following documents (ONLY Online submissions for all the documents.)

Added Para:

l) The bidder should submit blank proforma invoice from the foreign manufacturer along with his technical bid, duly mentioning the specifications and code number of the parts quoted.

m) The original proforma invoices from the foreign principal will be applicable in case of 100% subsidiary companies incorporated in India also.

(ii) PRICE BID (ONLY ONLINE).

Added Para:

3) The bidder should submit the original proforma invoice from the foreign manufacturer along with the price bid.

4) The bidder should not quote in Indian Rupees any foreign product, which are not already imported at the time of submitting the tender. Price bid in INR, if the product is not imported in India will not be considered and will be ignored.

F. SCRUTINY AND EVALUATION OF TENDERS

27.5 The following are some of the important aspects, for which a tender shall be declared non-responsive during the evaluation and will be ignored;

Added Para:

Violation of any of the conditions mentioned in GIT Clause(22.1 (i) (1 & m)) and 22.1(ii)(3&4) will make the bid non-responsive

All other terms and conditions of the tender enquiry remain unaltered.
