1. **The Bid must be accompanied by EMD of Rs.10,000/-(Rs.Ten Thousand only)** by the way of Demand Draft, drawn in favor of HLL Lifecare Limited., payable at Ernakulam. Bid received without EMD will be rejected.
2. **Tender Fee of Rs.200/- ( Rupees Two Hunded only)** to be paid at HLL ,Kakkanad for collecting the bid document (or download from the website and attach a separate DD of Rs.200/- in favor of HLL Lifecare Ltd, Kakkanad payable at Ernakulam.
3. The last date & time of receipt of Bid : 3 PM, 10.06.2015
4. Date of opening of bid : 3.30 PM , 10.06.2015
5. Tender Opening Venue : HLL Lifecare Ltd, CSEZ,Kakkanad

Terms & conditions are given below.

## **TERMS & CONDITIONS OF TENDER DOCUMENT**

- a) Rate offered should be the basic rate. The rates should be quoted on per Kg. basis in Annexure -2 attached. The party should have valid PAN, TIN registrations, Import-Export Code & Bank Account in any Nationalized (or) scheduled bank.
- b) 1. The total payable value is the ***total base price with its VAT/CST, Landing Charges, TCS*** by the way of DD, drawn in favor of HLL Lifecare Ltd., Ernakulam must be submitted well in advance at HLL, Kakkanad before the clearance of the scrap materials.
2. ***The duties related with SEZ are required to pay at Cochin Special Economic Zone by the awarded party***, the details to be submitted at HLL. Regarding the details about SEZ related duties the interested bidders may visit [www.csez.com](http://www.csez.com) (or) contact Sales Dept., HLL, Kakkanad.
- c) The rate should have validity during the entire Fin. year 2015-16.
- d) The Rubber scraps are offered in 'As is where is condition'. The company will not entertain any complaints on the quality, quantity, etc after the materials were taken by the buyer.
- e) The quantity for the entire period of 2015-16 mentioned is approximate only. Intimation will be done when some reasonable (Aprox. One vehicle load) quantity is accumulated. So the payment would be made on actual measurement of that quantity only. The Contractor should arrange for the removal of the available scraps within 7 (SEVEN) days of the phone/email intimation. The contractor shall take out the scraps preferably on office hours.
- f) The bidders are required to submit an EMD of Rs.10,000/- (Rs.Ten Thousand only) by the way of DD, drawn in favor of HLL Lifecare Ltd., payable at Ernakulam. This amount does not carry any interest.. The EMD amount of the unsuccessful bidders will be returned within one week after the opening of the Tender. The EMD amount of successful Bidder will be released after the successful completion of the contract period
- g) If the awarded party is not taking out the scrap materials within the allotted time frame without any unavoidable circumstances like vehicle strike, natural calamity etc, the contract will be cancelled and the EMD amount shall not returned to the party. Then HLL may consider the next highest party to award the contract.
- h) The bidder shall furnish the declaration form given in Annexure-1 , the rates in the Price Bid form given in Annexure-2 and submit those along with the sealed bid.

- i) The completed Sealed Tenders, addressed to **Dy.Manager (Sales) ,HLL Lifecare Ltd., Plot No-16/A-1,Cochin Special Economic Zone,Kakkanad,Cochin-682037** along with required EMD must reach the addressee **on or before 10.06.2015 (before 3 pm)**. The tenders to be super-scribed as **‘TENDER FOR KFC RUBBER SCRAP’**. The Tenders received before 3PM would be opened at 3.30 PM on 10.06.2015. The late and incomplete Tenders & the Tenders without EMD will be rejected.
- j) The vehicle for loading the scrap materials should report before 9 AM at our security gate during company working days. The contractor at his cost shall arrange the weighing and loading of the scrap materials. The vehicle loaded with scrap materials will be checked out by authorized representative of HLL. The scrap materials once sold would not be taken back.
- k) Any accident or loss of life while loading the materials would be solely the responsibility of the contractor. HLL would be in no way entertain any claim in this regard.
- l) The contractor should ensure that no damage or loss is caused to the company property while clearing the scrap materials and the contractor is liable to make good such damage/loss immediately, if any, as per the decision of HLL.
- m) The contractor shall ensure that the persons engaged by them for handling the scrap materials at the factory are not indulging in any malpractice, pilferage, etc.
- n) All disputes or differences whatsoever arising between the contractor and HLL shall be settled by arbitration in accordance with the Rules of Arbitration of the Indian council of Arbitration and the awards made in pursuance there of shall be binding on both parties
- o) The Bidders are required to sign on all pages of the tender Document.
- p) ) HLL has the right to reject any Tender without assigning any reason.
- q) Non- compliance of any of the terms and conditions would tantamount to automatic termination of the contract & forfeiting EMD.
- r) Scrap materials can be inspected during office hours on any working day after obtaining prior permission from the authorized representative of HLL.
