**SH:** Extension of Date of Sale , Pre-bid Meeting and Amendment of Eligibility Criteria

1. The Sale of Bids of subject work is extended as per dates mentioned below:

a	Period for issue of Bid/tender Document	From 07.01.2014 to 21.01.2014 between 11.00 hours & 16.00 hours every day except 2 <sup>nd</sup> & 4 <sup>th</sup> Saturday, Sunday and Public Holidays
b	Last date for receipt of request for issue of tender document	Till 21.01.2014 (15:00 Hrs.)
c	Last date for submission of queries	22.01.2014 by 5.00 pm
d	Pre bid meeting	On 24.01.2014 at 11.00 Hrs.
e	Date for issue of addendum	27.01.2014 addendum will be available at website of HLL and CPP portal
f	Last date of submission of Bids (at HLL Noida)	31.01.2014 at 15.00 Hrs
g	Date of opening of Technical Bids	31.01.2014 at 15.30 Hrs

2. The Para 1.4 of Vol. – I: - NIB & ITB of Eligibility Criteria is amended as under:

**Eligibility Criteria:**

Tenders will be issued to all intending & eligible Contractors/Firms. However, the Tenderer should meet the following minimum eligibility criteria:

- (a) The tenderers must be in existence as a contracting firm at least since last 7 years ending last day of the month previous to the one in which applications are invited.
- (b) Experience should be in the name of the tendering company and not in subsidiary/ associate company/ group of companies.
- (c) (i) Experience of having successfully completed works as detailed below during the last 7 years ending last day of the month previous to the one in which applications are invited:-

Three similar completed works each costing not less than the amount equal to 40% of Rs 5 (Five) Crores.

**Or**

Two similar completed works each costing not less than the amount equal to 60% of Rs 5 (Five) Crores.

**Or**

One similar completed work of cost not less than the amount equal to 80% of Rs 5 (Five) Crores.



**And**

(ii) One Completed work of any nature (either part of c (i) or a separate one) costing not less than the amount equal to 40% of Rs 5 (Five) Crores with some Central Government Department / State Government Department/Central Autonomous Body/Central Public Sector undertaking/ State Autonomous Body/ State Public Sector Undertaking.

- (d) **"Similar Works"** shall mean a Project comprising Construction of any Building work.
- (e) JV/ Consortium are not permitted.
- (f) The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to the last date of receipt of applications for tender.
- (g) **Turnover:** Average annual financial turnover on construction works should be at least 50 % of Rs 5 (Five) Crores during the immediate last three consecutive financial years. The turnover will be considered only for bidding company and not for group of companies or subsidiary company etc.
- (h) **Profit / Loss:** The Company should have positive Net Worth and should have not occurred loss in more than 2 years in last 5 years ending F.Y. 2012-13 duly certified by the Chartered Accountant.
- (i) **Solvency Certificate:** Solvency of the amount equal to 40% of Rs 5 (Five) Crores.
- (j) The bidding capacity of the contractor should be equal to or more than Rs 5 (Five) Crores. The bidding capacity shall be worked out by the formula;

$$\text{Bidding Capacity} = (A * N^2) - B$$

Where

A= Maximum Value of construction works executed in any one year during the last 7 years taking in to account the completed as well as work in progress.

N= Number of years prescribed for completion of work for which bids has been invited.

B= Value of existing commitments and ongoing works to be completed during the period of completion of work for which bids have been invited.

3. All other terms & conditions of the Bid document shall remain unaltered.
