TERMS& CONDITIONS:

1. ALL STATUTORY LEVIES, IF APPLICABLE, WILL BE DEDUCTED FROM CONTRACTOR'S BILL AS PER RULES.
2. THE PARTY SHALL TAKE ALL SAFETY PRECAUTIONS RELATING TO THE WORK ON CONTRACT AND IN THIS RESPECT NECESSARY SAFETY PERMIT SHALL BE OBTAINED BY THE PARTY FROM THE SAFETY DEPARTMENT OF THE COMPANY BEFORE COMMENCING THE SERVICE/REPAIR WORK.
3. THE WORK SHOULD BE CARRIED OUT WITH OUT CAUSING ANY INCONVENIENCE TO THE FACTORY WORK AND SHALL ENSURE THAT NO DAMAGES OCCURRED TO THE EXISTING PLANT AND MACHINERY.
4. THE WORK SHOULD BE CARRIED OUT IN CONSULTATION WITH THE AUTHORIZED OFFICER ASSIGNED.

1. INCOME TAX:

Prefereably within 30 days after satisfactory completion of work duly certified by Competent Authority

6. SECURITY DEPOSIT:

For placing orders, the bidders shall furnish Security Deposit @5% of total value of order in the form of DD favoring HLL Lifecare Ltd.

The above tender/order is liable to be suspended/cancel at any time at the discretion of the company with/without assigning any reason. You shall have to provide a certificate confirming that the machine/recruitment/product/ process being offered by you that environment friendly, i.e. it is non-hazardous to the environment.

Sub: Supply of Water Through Tanker in Summer Season – Reg.

- 1. Party shall quote rate for summer season (April to July).**
- 2. Vendor should supply clean water on daily basis consistently.**
- 3. Party shall make his own arrangements of water and power resources to ensure consistency in water supply.**
- 4. Quantity of water to be supplied by the contractor may vary from time to time as per HLL requirement.**
- 5. Quantity of water to be supplied by party will be decided by HLL.**
- 6. Party shall take all necessary precautions to ensure safe supply of water on regular basis.**
- 7. In case of agreement contract proof also should attach to show the source is having sufficient yield in the recent past.**
- 8. Servicing and supply of water is the sole responsibility of the contractor.**
- 9. The supplied water will be tested in our laboratory for ph, suspended solids etc.(allowable value ph 6.25 and suspended solids 5 mg/l).**
- 10. If the contractor fails to supply the water as per our requirement penalty will be imposed. The amount to be paid as penalty will be the actual amount that we are going to incur in bringing the water to our site on our own plus additional amount of 10% of the actual expensed incurred.**
- 11. If the supplier fails to supply the water, the same will be treated as Non-Performance and penalty will be imposed at the discretion of management and the matter cannot be referred to court.**
- 12. Contract period will be from 01/04/2015 to 31/08/2015 & 01-04-2016 to 31-08-2016 (totally 10 months in two years) . This period may very depend upon rain and availability of water.**
- 13. No advance will be given against the said contract.**
- 14. HLL Lifecare will not give any compensation; in case of water is not required due to some unforeseen reason. Force majeure clause is applicable.**



ANNEXURE

Sub: Supply of Water Through Tanker in Summer Season – Reg.

15. HLL Lifecare Ltd., reserves the right to cancel and may vary the period of contract without paying any compensation whatsoever on account of any alternate arrangements made to meet the requirement of water.
16. In case no reference is made to taxes it would be presumed that the taxes are not applicable and the commercial evaluation would be done accordingly.
17. No idling charges will be paid by the company.
18. In case of failure /breakdown of vehicles, the contractor has to make an alternative arrangement to avoid delay.
19. Updated emission test certificate from appropriate authority and driving licence should be produced whenever required.
21. Water should be supplied through tanker registered as per carriage by road act 2007.
22. The supplier has to deposit an amount of Rs. 15,000/- as Security Deposit (in case of placement of order) and the same will be returned after the expiry of the contract.
23. In case of failure /breakdown of vehicles, the contractor has to make an alternative arrangement to avoid delay.
24. In case of agreement contract proof also should attach to show the source is having sufficient yield in the recent past.
25. EMD of Rs. 15,000/- (Rupees Fifteen Thousand Only) should be submitted along with the quotation by way of demand draft drawn in favour of M/s. HLL Lifecare Limited, Kanagala payable at Nipani. Tenders without EMD will be liable for rejection.
