

**Minutes of Pre Bid Meeting held on 19<sup>th</sup> September, 2017 at HML Chennai office, on the Tender for Construction of Site Grading, Roads and Storm water drainage system for Medipark, Chengalpattu, Kancheepuram district, Tamil Nadu**  
**Ref: Tender no. HML/INFRA/01/17 dated 12<sup>th</sup> September, 2017**

The tender for the Construction of Site Grading, Roads and Storm water drainage system for Medipark, Chengalpattu, Kancheepuram district, Tamil Nadu was published on 12<sup>th</sup> September, 2017. The pre bid meeting was held on 19<sup>th</sup> September, 2017 at HLL Medipark Limited, Velacherry, Chennai at 12:00 Hrs. The following are the queries raised by the participants and the clarifications provided by HML. These clarifications shall form a part of the tender document.

1	For eligibility criteria. We have been asked for 3 works of Rs. 582 lakhs and 2 works of Rs. 727.5 lakhs and single work of Rs. 1164 lakhs and if we have done a sub-contract from a company and we have completion certificate from the recognised Concern, is this sub-contract will be concerned for the eligibility.	Experience should be in the name of the bidding firm and the value of similar works should be satisfied as per the clause 3 of ITB (Eligible bidders)
2	We had executed a contract in the name <b><u>Improvement and additional facilities to the fishing harbour in Chennai</u></b> in which We had executed works like site levelling, forming roads, RCC platforms, compound wall, drains, building works which includes civil works, electrical and other allied works. Hope this work shall be considered as similar works. (Book 01 GCC)	Bidders' eligible criteria shall be satisfied as the Clause 3 of ITB.  The decision to consider as similar works will be taken based on the quantum of works executed on each items in the contract.
3	With reference to the clause we understand that the contractor has to pay 2% cess on contract value – please clarify is that correct or will HLL pay this and contractor need not consider this amount into his prices. (Book 01 GCC)	Will be applicable as per the current applicable tax policies.
4	Any new taxes/duties/seniorages /royalties or any amendment to the existing taxes/duties/seniorages /royalties are implemented by state or central government after the tender date the increase or decrease will be passed on to HLL please confirm .	As per tender document
5	As all the river sands in Tamilnadu state are banned for quarrying and it's impossible to source river sand hence we request to approve M sand shall be used in this projects.	M Sand can be allowed to use for the project on submission of necessary and satisfactory test reports.
6	Stores/office/labour Camp etc Will there be any charges to be paid by the contractor for establishing these facilities.	No. However, Contractor has to make their own arrangement for the establishing the required facilities.

7	We request HLL to provide water and electricity in one point for construction purpose and labour usage.	No. Contractor has to make their own arrangement for the construction water and power.
8	We request to fix the maximum of 5% of the contract value as liquidated damages instead of the 10% mentioned in the tender.	As per tender document
9	In the eligibility criteria says "Bidders shall have experience of having successfully completed works during the last 3 years ending last day of the month previous to the one in which applications are invited." We request you to change as 5 years instead of 3 years.	As per tender document
10	Whether Construction of ROB which involves major quantity of Earth-work, Cutting, Forming Embankment, Forming Approach Roads including GSB, WMM & Bituminous Work/RCC Works can be qualified for the work.	Bidders' eligible criteria shall be satisfied as the Clause 3 of ITB. The decision to consider as similar works will be taken based on the quantum of works executed on each items in the contract.
