The supplies of all products should be from fresh stock only. At the time of receipt of medicines, they should have the latest manufacturing date with minimum 70% of the shelf life remaining. Products to be supplied should be of standard quality/quantity as per **USP/BP/EP** and must be as per the formulations/standard approved/specified by the Drug Control Act and Food & Drug Control Administration Regulation or as per

the regulation of any such statutory authorities. All the Dry Powder and Liquid Injectables are to be manufactured as per **USP/BP/EP** standards.
