

Minutes of Pre-Bid meeting held at JIPMER, Puducherry at 03:00 PM on 03.06.16 for the work Establishment of IVF LAB at WCH Block for JIPMER, Puducherry against Tender No. HLL/DS/IVF-JIPMER/16/03 Dated: 26.05.2016.

The queries raised by the prospective bidders and the clarification given by HLL/JIPMER is detailed below:

Query 1: The list of equipments given in the tender are basically general medical equipments, the IVF equipments are very few. Whether more IVF equipments will incorporate in the tender?

Reply: The list of equipments, if any required shall be issued through an amendment.

Query2: As per tender the insullation/ fabrication work should be done on stainless steel. whether this can be changed to Aluminium?

Reply: To be done as per tender document.

Query3: Since, there is difficulty in getting approvals from government authorities, the statutory clearance and charges shall be taken care of JIPMER ?

Reply: All the statutory clearance shall be done by the contractor, no additional charges will be paid. However, documents if any required from JIPMER shall be provided upon request.

Query4: The 'similar works' define in qualification criteria is mentioned as establishment of IVF lab, whether the term can be generalised ?

Reply: This lab is different from other lab constructions, so the contractor should have experience as defined in tender.

Query5: After successful installation and commissioning, how many cases have to be done by the contractor? What is the duration for operating the lab by the contractor? Whether the cost to be included separately in the tender?

Reply: It is desirable to ask the bidder to quote the rates for 50 cases/ 6 months whichever is earlier. However, the expense being of a revenue nature is not included in the capital project cost and can be met by JIPMER cost.

HLL with approval from JIPMER instructed all the prospective bidders to visit the site. Shri.Karthik.P- Deputy Manager- HLL had guided all the prospective bidders for site visit immediately after the meeting.
