2. Canvassing in any form will be a disqualification.
3. Candidates are requested to bring all their certificates in original along with attested copies to prove age, Qualification, Mark sheets / Experience certificates / latest salary certificate with break-up / Aadhar / PAN / Latest passport size photograph etc for verification, which has to be produced at the time of verification of certificates. SC/ST/OBC (non-creamy layer) candidates should produce their Community Certificate in original from the concerned Revenue Authorities. Failure to produce the above certificates in the original will disqualify from appearing for the selection test.
4. The appointment will be on a **Fixed Tenure Contract** basis.
5. The proposed place of posting shown in the detail may vary as per the business requirement, management keeps the right for the final place of posting as deemed fit.
6. Only candidates with relevant **QUALIFICATION** and **EXPERIENCE** will be permitted to attend the written test.

7. Candidates applying for the Pharmacist shall submit the **State Pharmacy Council Registration** to us in order to get a License for the Pharmacy outlet.
