## II. TERMS & CONDITIONS

### 1. Price

The price quoted should be inclusive of all labour charges, cost of Materials & consumables, rental charges of tools & equipment's, all applicable taxes and other levies etc. for completing the work as per Schedule.

Price quoted should be firm without any escalation till the order is completely executed. **Schedule of Work enclosed** as Annex- A.

### 2. Completion Time

The work should be completed within 21 **days** from the date of issuing the Letter of Indent or work Order or date of site clearance from HLL for respective areas.

### 3. Payment Terms

Payment will be made only after successful completion of work and against actual measurements recorded and certified jointly by HLL Engineer in charge and the Contractor's representative. 5% amount of the Bill will be retained as retention money and will be released only after the Defect liability period of 12 months.

### 4. Tax Deduction:

All statutory deductions like Income Tax, Works Contract Tax, E.S.I., P.F. or any other government-imposed liabilities shall be borne by the Contractor (as applicable at the time of execution of job) and shall be deducted from each bill submitted by the Contractor.

#### 5. SSI/ MSME

a. 25% of annual procurement value will be sourced from Micro and Small Enterprises (MSE), out of which 4% is earmarked for procurement from MSE's owned by SC or ST entrepreneurs and 3% is earmarked for procurement from MSE's owned by Women entrepreneurs. In the event of failure of SC or ST or Women entrepreneurs to participate in tender or meet tender requirements/conditions regarding price the same will be sourced from others.

b. Start up units interested in availing exemption from payment of tender fee & EMD shall submit a valid copy of Registration Certificate from Department of Industrial Policy & Promotion on or before due date as per tender notice. But the party has to provide security deposit if Tender is awarded to them.

6. The scheduled date for receipt of bids is **01-03-2021 up to 15.00 HRS.** and opening of **bids is on 01-03-2021, 15:30 HRS**
