Eligibility Criteria

The eligibility criteria for application of prospecting applicants for consideration of selection are provided as under:

1. General Qualification

The applicant must have MD (Radiodiagnosis) /
DNB (Radiodiagnosis)/ DMRD (Radiodiagnosis) qualification.

2. For MRI Reporting

- a. The applicant must have immense experience in 1.5 tesla MRI for more than 1 year (Post qualification) with above 5000 numbers of MRI reports. (Please submit a self-declaration mentioning this along with the application)
- b. The applicant must have sufficient reporting experience in all the special procedures in MRI.

3. For CT Reporting

- a. The applicant must have immense experience in Multi Slice CT reporting for more than 1 year (Post qualification) with above 10000 numbers of CT reports. (Please submit a self-declaration mentioning this along with the application)
- b. The applicant must have sufficient reporting experience in all the special procedures in CT.

4. For Conventional Radiography Reporting

- a. The applicant must have immense experience in reporting conventional Radiography including plain and contrast X-ray radiography for more than 1 year (Post qualification) with above 1000 numbers of X-ray

reports. (Please submit a self declaration mentioning this along with the application)

b. The applicant those who have sufficient reporting experience in the special procedures in conventional radiography like X-ray mammography, IVU, IVP, HSG etc should mention the same in detail.

5. The applicant must have experience in the operations of teleradiology reporting software and should be able to provide the reports with lesser TAT.

Each applicant has to provide proof for their eligibility while expressing their interest.

HLL will have full discretion to select the number of radiologists in the panel. HLL reserves the right to accept or reject any application and cancel the bidding process at any time without any liability and assigning any reason thereof.
