Sub: Amendment to the Tender inviting Selection of agency for web hosting services, implementation of online/ e- pharmacy software & its logistics management

Ref: IFB No. HLL/RBD/2017-18/01 DT. 12-07-2017

With reference to the above, we here by incorporate the following amendment to the tender documents as detailed below;

1. Annexure I- Format for Price Bid

The format for Price Bid has been **revised** including a one-time fee payable upon successful development & integration of the software/e-pharmacy platform and the commercial start of operations, and the revised format (incorporating Table.3) is enclosed herewith as **Annexure -1**

2. Consequent to the Change in price Bid format, the Evaluation of Price Bid and the relevant weightages to the Price Bid components has been revised/introduced as under;

2.a) Page 18: Clause 18.3 Evaluation of Price Bid

Sub Clause 1) - Evaluation of Table 1 of price bid;-Weightage of 90%

The weightage of 90% assigned to Table 1 of Price bid is amended to 50% and may be read as "**Sub Clause 1) - Evaluation of Table 1 of price bid;-Weightage of 50%**

The illustrations demonstrated in this regard may be reworked considering a weightage of **50%**

2.a) Page 18: Clause 18.3 Evaluation of Price Bid

Sub Clause 2) - Evaluation of Table 2 of price bid;-Weightage of 10%

The weightage of 10% assigned to Table 1 of Price bid is amended to 20% and may be read as "**Sub Clause 1) - Evaluation of Table 1 of price bid;-Weightage of 20%**

The illustrations demonstrated in this regard may be reworked considering a weightage of **20%**

2.c) Page 19: Clause 18.3 Evaluation of Price Bid

In view of the change in Price Bid format, a new sub clause 3) has been added as under;

Sub Clause 3) - Evaluation of Table 3 of price bid;-Weightage of 30%

The bidder must quote an amount as the One- time fee payable upon development, deployment & integration of the software/e-pharmacy platform to enable the commercial start of operations.

For obtaining the weighted value of each Bidder, the L1 bid amount would be divided by the bidder's bid amount. Each value so obtained will be multiplied by 30% (weightage) in order to obtain the weighted value of each party

The same is illustrated below with example

Example: -Weighted Value of Table3

Amount quoted by Bidder A is 100000

Amount quoted by Bidder B is 200000

Amount quoted by Bidder C is 300000

Bidder A in the above scenario has quoted the lowest amount and so is the L1 value.

Weighted value calculation of Bidder A

Step 1= $(100000/100000) = 1,$

Step 2= 1 (obtained in Step 1) $\times 30\% = 30 \%$

Weighted value calculation of Bidder B

Step 1= $(100000/200000) = 0.5,$

Step 2= 0.5 (obtained in Step 1) $\times 30\% = 15 \%$

Weighted value calculation of Bidder C

Step 1= $(100000/300000) = 0.33$

Step 2= 0.33 (obtained in Step 1) $\times 30 \%$ = 10%

NB: Overall score of the bidder for final comparison (Weighted value of Table 1+ Weighted Value of Table 2 + Weighted Value of Table 3)

3. The last date of date for receipt and opening of bid of the above referred tender has been amended as follows.

(a) Last date and time of receipt of Bids	22-08-2017 15.00 Hrs
(b) Date and time of Opening Technical bid	22-08-2017 15.30 Hrs
