In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
4. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued

by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery

time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

1. The next-generation sequencing (NGS) system should be a compact benchtop model with minimal footprint and able to support multiple sequencing applications: 3' gene expression, RNA sequencing (RNA-Seq), including mRNA-Seq and total RNA-Seq (coding and noncoding), Targeted RNA panels, Pathogen detection, 16S amplicon sequencing, Shotgun and shallow shotgun metagenomics, Small whole-genome sequencing, Amplicon-based targeted sequencing, Enrichment-based targeted sequencing, Genome editing, Immune repertoire, Library QC, etc.
2. Single instrument performs clonal amplification, sequencing, paired-end run and primary data analysis and secondary data analysis and should require minimal touch points.
3. The manufacturer should also offer kits and reagents for library preparation from DNA/RNA.
4. System should offer flexible scalability to generate 1.5 to 30 Gb and up to 100 million single end reads or 200 million pair end reads to support a broad range of applications, including metagenomic sequencing, de-novo sequencing and re-sequencing of microbes, complete de-novo sequencing and re-sequencing of higher eukaryotes including human genome, ChIP sequencing, transcriptome sequencing (microbial, plants and human), etc.
5. The system should have onboard cluster generation followed by integrated massively parallel sequencing of DNA/RNA libraries loaded directly on the integrated sequencing cartridge. The sequencing chemistry should offer both single end and paired end sequencing (100, 300, 600, 1000 cycles) to be completed in 4-24 hours and prepares FASTQ files as part of the sequencing run, without need of extra equipment or steps.
6. The sequencing reagent should be shipped and stored at room temperature to avoid use of dry ice and cool-packs and does not require washing, enables streamlined instrument maintenance, and optimizes instrument efficiency. The design of sequencing cartridge should allow recyclability and minimizes waste volume.
7. The sequencing technology should offer accurate sequencing of homopolymers and highest read quality score of Q30 for more than 90% for 2x150 cycle and >85% at 2x300 cycle of the base calls having >99% accuracy ensuring quality control steps.
8. System should have inbuilt hardware for ultra-rapid secondary analysis for a wide variety of genomic analysis solutions, including base call (BCL) file conversion, mapping, alignment, sorting, duplicate marking, and variant calling without the need for bioinformatics expertise.
9. The on-board analysis hardware should use optimized, hardware-accelerated algorithms.

orithms for a wide variety of genomic analysis solutions, including base call (BCL) file conversion, compression, mapping, alignment, sorting, duplicate marking, and variant calling. Pipeline for whole exome, targeted resequencing, whole transcriptome expression and fusion detection.

10. System should also offer cloud-computing platform for simplified data management and analytical sequencing tools directly to researchers in a cost effective and user-friendly format.
11. System should be able to sequence multiple samples at a time with option of using barcodes for sample multiplexing (up to 384).
12. The system should include latest software, hardware, accessories, and technology available at the time of installation which is needed for generating high quality sequence reads.
13. The system should be user installable and run set up could be complete in less than 20 min with minimum step.
14. For running the NGS machine below accessories instrument will be supplied along with the instrument. (Workstation for Data storage and processing: 16GB RAM, 8 Core Processor 2TB Storage, Server: 24 GB RAM, 16 Core Processor, 20 TB Storage, Thermo Mixer, Qsep one Plus, Hybex heating system, Midi Plate heat block, UPS (5 KVA) 30 Min back up, Magnetic stand-96 well plate (Ambion), Magnetic stand and 1.5/2 ml tubes (DynaMag 2), Dehumidifier for sequencing room, Qubit Fluorometer for quantitation, Vibration Free Table)

Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents (other than EMD and signed Integrity Pact - which can be submitted within 5 days of bid opening) in physical form as a pre-requisite to qualify bidders.

5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. 8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
