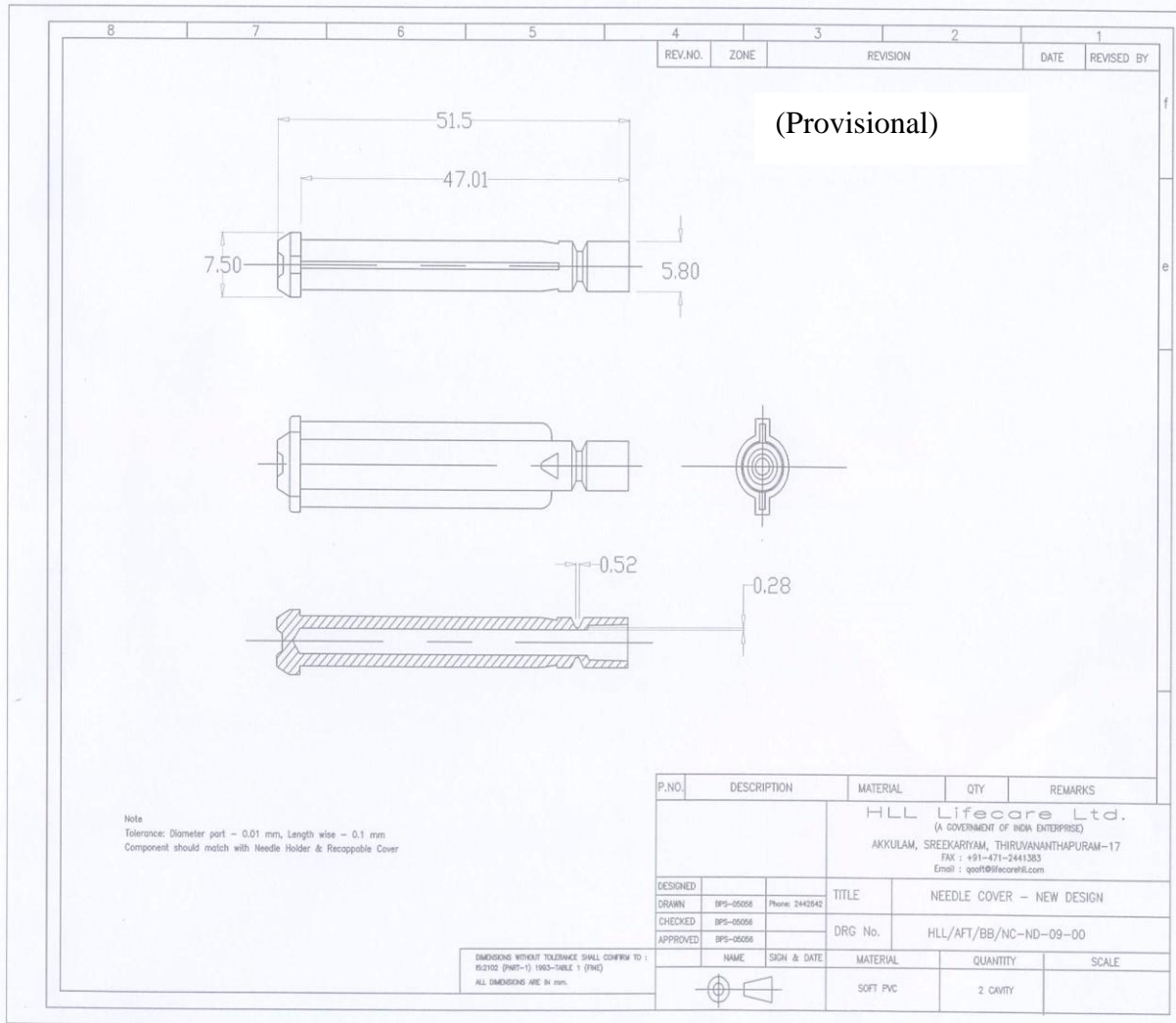

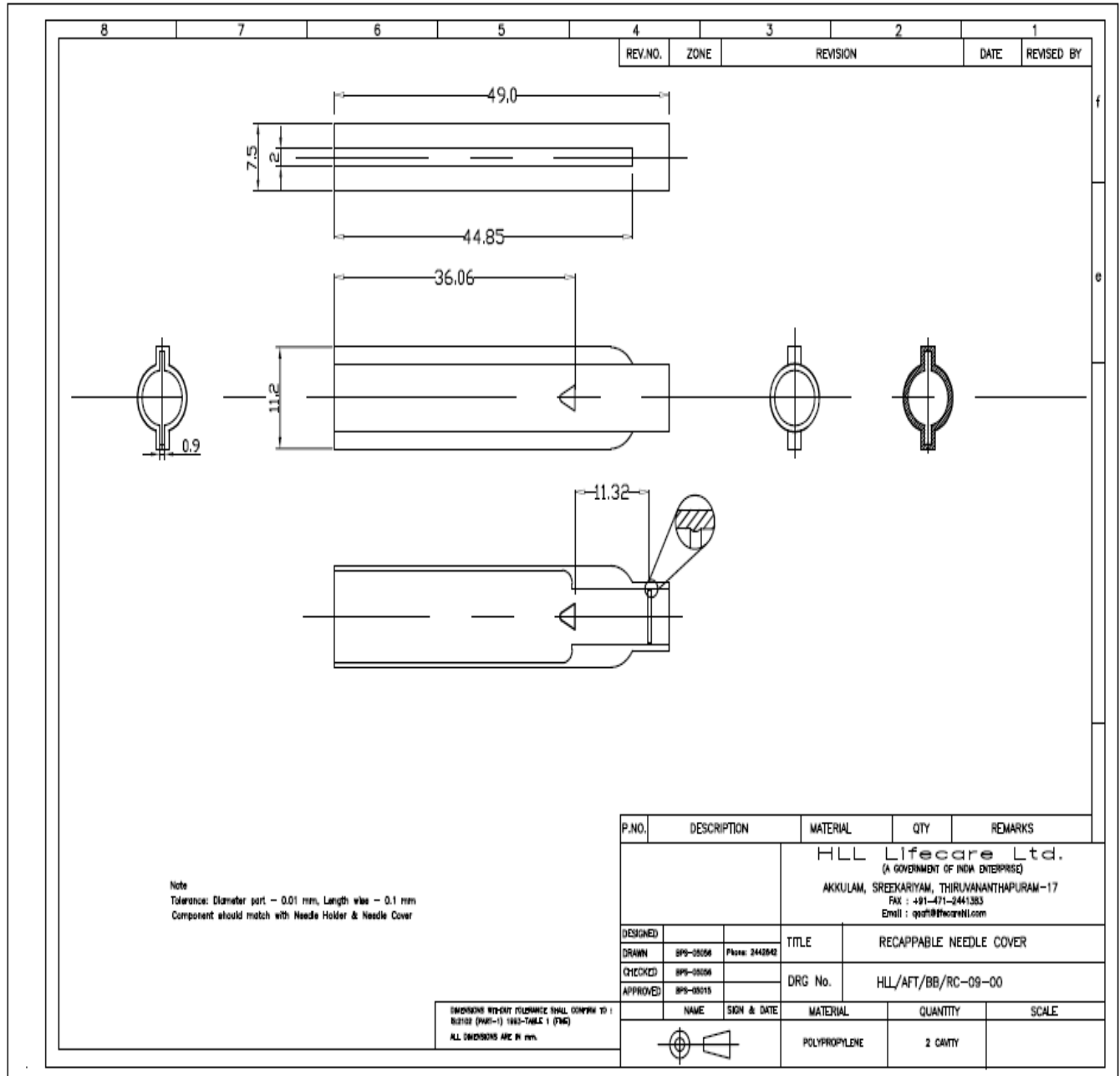

OTHER GENERAL REQUIREMENTS

1. Moulding facility: Supplier should have a Class 1 Lakh (ISO Class 8) clean room facility for the Injection moulding, Components Inspection, Assembling and Primary packing.

2. Injection Moulding Machine: The supplier should have at least one 80 Ton (minimum capacity) good condition Injection moulding machine and same must be kept and operate in Class 1 Lakh clean room.

3. Injection Mould (8 / 16 Cavity): The supplier must fabricate and maintain the Injection Mould (HLL will not bear the Tool cost and maintenance cost)

4. Mould Fabrication and Maintenance: The supplier should have a mould fabrication facility / tie-up with reputed mould manufacturer for the design, fabrication and maintenance of Injection moulds.

5. Autoclaving Facility: The supplier should have a laboratory type autoclave / pressure cooker type sterilization equipment for performing the autoclave test of components.

6. In-process Inspection: Component must be free from flash, bend, embedded dust, black spot, colour change, silver streaks, ovality, deformation at gate point, cracks / hole in the pinch off area of PVC Needle cover, etc. The components must also comply with the dimensional requirements as per the approved drawing.
Frequency of inspection: Every one hour on 3 consecutive shots and the results should be recorded in the production/inspection log sheet.

7. Autoclaving requirement: Components must be free from crack, bend, puncturing at gate point, puncturing of Pinch off Area of PVC Needle cover and excess shrinkage after Autoclaving. (118°C, 35minutes /121°C, 25 minutes).
Frequency of inspection: Every 4 hours on 3 consecutive shots. Allowable shrinkage after autoclaving is less than 8% for PVC component and less than 5% for PP component.

OTHER GENERAL REQUIREMENTS

8. Visual Inspection: 100 % visual inspection – all the components must be inspected against visual defects and it must be ensured that, the component are free from flash, bend, embedded dust, black spot, colour change, silver streaks, ovality, deformation at gate point, cracks / hole in the Pinch off Area of PVC Needle cover, wall thickness variation, etc.

9. Packaging: 500 sets of assembled components in a LDPE Cover of 70 micron thickness and such 10 to 15 packets in a master carton having burst strength of 15Kg/cm² and it must be stretch wrapped with LLDPE stretch film of thickness not less than 23 micron.

10. Pre shipment Inspection: Each batch of finished components must be inspected and ensure that, the lot is fully complies with the quality and quantity requirements.

11. Documents: Components must be supplied along with the necessary production & QC documents contain the following details as per the format required by HLL.

a) Production document: Comprising date of production, Name of the operator, Product batch No, Total Qty. produced, Accepted Qty., Rejected Qty., Type of rejection, raw material batch No., Process parameters (Temperature, Pressure, Speed, Injection Time, Hold on time, Cooling time, etc.)

b) QC Document: Contains the details of in-process inspection, finished product Pre shipment inspection details (Batch No, Date, Time, Sample size, Product quality status, Instruments / gauges used, etc.) and PVC raw material test certificate from the supplier.
