**TERMS AND CONDITIONS FOR HIRING OF VEHICLE FOR  
OFFICIAL USE ON CONTRACT BASIS**

- 1) **The tenderer must be the owner of vehicle. The vehicle should be registered after January 2012. Copy of the RC book to be enclosed along with the tender to prove the ownership and year of Registration.**
- 2) **The bidder should not offer vehicle which are already under contract with other units of HLL or with any other organization.**
- 3) **An EMD of Rs.5,000/- (Rupees five thousand only) by way of Demand Draft drawn in favour of HLL Lifecare Limited, Trivandrum payable Thiruvananthapuram should accompany the tender. Tender without EMD will be summarily rejected.**
- 4) **The rate should be quoted in the enclosed format.**
- 5) **An amount of Rs.10,000/- is to be remitted as security deposit by the successful tenderer for the vehicle.**
- 6) **The Earnest money of successful bidder/s will be converted to Security deposit and they will be required to remit only the balance amount. EMD remitted will be forfeited if the successful tenderer withdraws after opening the tender.**
- 7) **The Contractor shall provide the vehicle along with driver having valid licence badge (if needed), good behavior and keep the vehicle in good running condition.**
- 8) **The rates quoted shall include wages to the driver, cost of oil, fuel, taxes, insurance, service charges etc. The Contractor shall solely be responsible for compliance of statutory and non-statutory requirements involved in providing the vehicle on monthly rental.**
- 9) **In case of any accident the contractor would be solely liable and HLL will not have any liability for the damages or compensation.**
- 10) **The contractor shall bear the cost of all the maintenance work of the vehicle provided. In case, the vehicle cannot be made available due to breakdown, Inspection etc., the contractor shall make alternative arrangements to provide substitute vehicle of the same category.**

- 11) **The driver and vehicle should be covered by valid Insurance and the Payment of compensation in case of any accident or otherwise shall be the responsibility of the contractor.**
- 12) **No advance will be given for the service provided by the contractor and the payment will be made only on monthly basis on presentation of bill and after statutory deductions such as Income Tax. The contractor should also ensure that minimum wages is paid to the driver and a certificate to this effect shall be submitted by the contractor along with the monthly bill. PF & ESI coverage applicable shall be the responsibility of the contractor.**
- 13) **The charges for additional Kilometers, if any, will be paid every month at the rates finalized.**
- 14) **If the services of the contractor are not satisfactory, HLL Lifecare Limited reserves the right to cancel the contract after giving 30 days notice.**
- 15) **In case the contractor fails to provide the vehicle on any day, the same will attract penalty and the additional expense incurred by the company in this regard for engaging vehicles from alternate sources will be deducted from the contractor bill / Security Deposit.**
