3. Payment will be released on monthly basis.
4. The rate should be inclusive of all viz., fuel, maintenance expenses, permit tax, Insurance and Service Tax / Other statutory levies etc., as applicable. Toll charges & parking charges will be reimbursed by us against proofs.
5. Statutory deductions if any will be applicable as per rules on party account only.
6. The vehicles should have valid Taxi permit.
7. The Vehicles provided to us, should fulfill all the requirements of state transport Authorities.
8. HLL Lifecare Ltd., will not be liable for any accident happened to the Vehicle and injury to the driver. Contractor alone will be liable for any compensation on account of any event.
9. The drivers engaged by you for driving the vehicles shall be contractor's employee's only and not of HLL Lifecare Ltd.,
10. Vehicles provided as above fails in its operations by Mechanical trouble or otherwise lack of driver etc., the Contractor shall provide to the company another vehicle of the same condition and sitting capacity without fail and shall make good of the loss or damage or difficulty experienced by the company on this account at the discretion of the company.
11. The finalized party after opening the tender should be ready to provide the Taxis from date confirmed by us.
12. Sub Contract is not allowed.
13. The vehicle should be provided as and when requested by us.
14. Should arrange personal accident insurance policy for the Drivers.
15. Drivers should have valid driving licence with uniform and Mobile phone facility.
16. The original documents of the vehicle should be always maintained in the vehicle with valid insurance is yours responsibility and at your cost only.

17. *Emission test should be carried out at the required intervals by you on your accounts and related data should be maintained in the vehicle.*
18. *Renewal of permit is your responsibility and on your account only.*
19. *The contractor should have Service Tax registration & PAN Card.*
20. *It is the responsibility of the contractor with respect to Police Department, Check post Authorities and RTO authorities etc.*
21. *In case of breakdown of vehicle during the journey the contractor should arrange for replacement immediately and at his cost only. If the breakdown is on the road the Company reserves the right to engage another vehicle from other sources and additional financial commitment incurred will be recovered from the contractor bill.*
22. *The contractor should have printed and serially numbered bill.*
23. *Before the start of journey the contractor should ensure full quantity of fuel required for the complete journey. No advance shall be paid for filling the fuel.*
24. *Relavant documents/papers pertaining to the vehicle should be maintained in the vehicle during the journey period.*
25. *Contractor is required to comply with all the applicable provisions of the Motor Vehicle Act & Rules and the Amendments from time to time.*
