Name of Tender - Construction of additional loading bays at New Storage Facility at Balaramapuram

The following amendment in ELIGIBILITY CRITERIA is issued herewith

ELIGIBILITY CRITERIA

I. FOR ENLISTED CONTRACTORS WITH HLL

1) They should have been declared or enlisted in category C (Tendering Limit Rs.5 crores) OR category D (Tendering Limit Rs.1 crore)

2) The bidding capacity of the bidder should be equal to or more than the estimate cost of the work. The bidding capacity shall be worked out by the following formula:

$$\text{Bidding Capacity} = A * N^2 - B$$

Where,

A = Maximum value of construction works executed in any one year during the last five years ending 31st March 2013, taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of work for which Bids have been invited.

B = Value of existing commitments and ongoing works to be completed during the period of completion of work for which Bids have been invited.

- 1) For enlisted parties, only the eligibility criteria are separate as above. They shall abide all other conditions in the tender including submission of EMD and tender cost.

II. FOR NON-ENLISTED CONTRACTORS WHO ARE INTERESTED TO PARTICIPATE

- a) The applicant should have an establishment in Kerala.
- b) The applicant should be a registered contractor of Central/State Government OR Central/State Autonomous Body OR Central/State PSUs or a standing contractor of HLL Lifecare Limited.
- c) Those who has done work/doing work in HLL shall produce completion/progress certificate from the Engineer in charge not below the rank of Project manager that the work is satisfactory. This is mandatory
- d) The applicant shall have the eligibility criteria and experience as follows.

D.1 The applicant should have satisfactorily completed during the last five years ending last day of the month of March 2013.

- 1. Three similar works each costing not less than Rs. 15.08 Lakhs or
- 2. Two similar works each costing not less than Rs. 22.63 Lakhs or
- 3. One similar work each costing not less than Rs. 30.17 Lakhs

The applicant should submit successful completion certificates for the above works. The certificate issued by Client should contain date of start, date of completion, value on completion etc. If the applicant has done/ doing any works at HLL, he should submit the satisfactory performance certificates from any officer not below the rank of Project Manager.

Cost of work shall mean gross value of the completed work including the cost of materials supplied by the employer/ client, but excluding those supplied free of cost. This should be certified by an officer not below the rank of Executive Engineer/ Project Manager or equivalent.

- e) The applicant should have had an average annual financial turn over (gross) of Rs. 11.32 lakhs on Civil construction works during the last three consecutive financial years ending 31st March 2013.
- f) The applicant should not have incurred any loss in more than two years during the immediate last five consecutive financial years ending 31st March 2013, duly certified by the Chartered Accountant.

g) The bidding capacity of the bidder should be equal to or more than the estimate cost of the work. The bidding capacity shall be worked out by the following formula:

$$\text{Bidding Capacity} = A * N^2 - B$$

Where,

A = Maximum value of construction works executed in any one year during the last five years ending 31st March 2013, taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of work for which Bids have been invited.

B = Value of existing commitments and ongoing works to be completed during the period of completion of work for which Bids have been invited.

h) The firms should be registered with Income Tax and Service Tax Authorities and copies of PAN and Service Tax Registration have to be submitted along with application.

i) The applicant should have sufficient number of Technical and Administrative employees as per clause 36(i) of General Conditions of contract for the proper execution of the contract. The applicant should submit a list of these employees stating clearly how they would be involved in this work.

j) The applicant's performance for each work completed during the last 3 years and works in hand should be duly certified by the authorized signatory of the client.
