M/s. HLL Lifecare Ltd invites EOI for the engagement of Pharma companies on loan licence/Purchase/ Contract manufacture of generic medicines.

## **1. COMPANY BACKGROUND:**

**HLL LIFECARE LIMITED (HLL)** is a 'MINI RATNA' PSU under the Ministry of Health & Family Welfare, Govt. of India involved in the sale of Generic Pharmaceutical Products through its HLL Pharmacy.

HLL intends to short list Pharma companies for loan license/ Purchase/Contract manufacture of drugs and pharmaceuticals as per the Schedule of requirement in **Annexure II**. HLL invites EOI from interested parties in the form of technical bids from manufacturer of the pharmaceutical products in generic name.

## **2. GENERAL SCOPE:**

The scope of the work shall include:

- 2.1 Manufacture of various Drugs/ Pharmaceuticals under loan license, Purchase or contract manufacture as per the intend of HLL Pharmacy situated at New Delhi.
- 2.2 Ensure strict compliance to all statutory regulations with furnishing of a "Certificate of Analysis" confirming to IP / NFI / BP/ USP or equivalent specification for each batch of all products purchased from the party.
- 2.3 Supply the medicines / drugs as per the artwork provided by HLL Lifecare Limited. The supplier should get the artwork samples duly approved from HLL before the final printing and supply.
- 2.4 The list of medicines are given in **Annexure II**.

#### **4. ELIGIBILITY/ QUALIFICATION CRITERIA:**

- 4.1. They should have all facilities for manufacturing and testing of tablets/ liquid Orals. They must submit the site master file.

**(FOR IFA ENTERIC COATED TABLETS, BIDDERS SHALL GIVE SELF DECLARATION THAT, THEY WILL OBTAIN LICENSE IN SHORTEST POSSIBLE TIME AND ALSO CERTIFY THE DELIVERY SCHEDULE WILL NOT GET AFFECTED)**

- 4.2. They should have minimum 2 crore turn over for the last 3 years for similar line of product. They must provide their last three years balance sheet.
- 4.3. They should have a valid manufacturing license valid on the date of Bid opening. Copy of manufacturing license along with the list of drugs must be provided.
- 4.4. Firm should have valid WHOGMP/GMP certificate issued by statutory authority valid on the date of bid opening.

#### **5 OTHER DOCUMENTS REQUIRED WITH TECHNICAL BID:**

- 5.1. Signed copy of Tender Document (all pages to be **signed & stamped**) `by Bidder as token of the acceptance of the Terms & Conditions.
- 5.2. Duly filled **Annexure I & II** of the Bid Documents you are interested in supplying
- 5.3. Sales Tax Clearance certificate.
- 5.4. PAN no. / Exemption certificate from Income Tax Department
- 5.5. Self- Declaration, No conviction certificate, as per **Annexure III**.
- 5.6. Self - Declaration for the drugs providing guarantee that the drugs supplied are not spurious.
- 5.7. Manufacturer's Authorization Form, as per **Annexure IV** of Bid Documents.
- 5.8. Replacement of market complaint goods, as per **Annexure V** of Bid documents.

#### **6. EVALUATION OF TECHNICAL AND PRICE BIDS:**

- 6.1 Bidders should submit the two bids in separate envelop indicating Technical and price bid.
- 6.2 The price bid of the only technically qualified bidders will be opened.

- 6.3 The price Bid shall be as per the format enclosed in the **Annexure VI**.
- 6.4 **It is the responsibility of bidder to submit authentic documents along with EOI to the satisfactions of purchaser to prove its eligibility. In absence of satisfactory documents, technical bids are liable for rejection and such bids/bidders PRICE BIDS shall not be OPENED.**
- 6.5 HLL reserves the right to inspect the manufacturing facility, if required at any point of time.
- 6.6 Special wattage shall be given to WHO-GMP certified company for specific product as per the requirement of various state / central Govt.
- 6.7 **Apart from the schedule of requirement. The Bidders can also quote any other formulations manufactured by them under the category of TABLETS, CAPSULES, LIQUID ORALS, INJECTABLES, and OINTMENTS AND POWDERS.**

## **7. GENERAL INSTRUCTIONS TO BIDDERS:**

- 7.1 Prospective Bidders may seek any clarification by mail on or before 28-01-2013 before 12 noon.
- 7.2 Bidders shall ensure that their tenders, complete in all respects, are received at HLL Lifecare Ltd. Kanagala- 591225, Belgaum, Karnataka, on or before the closing date and time indicated in the Bid Data Sheet as above, failing which the tenders will be treated as late and rejected.

## **8. ETHICAL STANDARD:**

Bidders are expected to observe the highest standard of ethics during the procurement and execution of this Contract. In pursuit of this policy, HLL will reject a proposal for award if it determines that the Bidder being considered for award has engaged in corrupt or fraudulent practices in competing for the Contract.

## **9. CLARIFICATION OF BIDDING DOCUMENTS:**

- 9.1 A prospective Bidder requiring any clarification of the Bidding Documents may notify the Purchaser in writing to, or by **e-mail : nateshk@lifecarehll.com** or at the purchasers mailing address indicated in the Invitation for Bids. The Purchaser will respond in writing to any request for clarification of Bidding Documents, with in 24 hours .this clause shall be read in conjugation with clause no 7.1
- 9.2 During the bid evaluation, the Purchaser may, at its discretion, ask the Bidder for a clarification of its bid. The request for clarification and the response shall be in writing, and no change in the price or substance of the bid shall be sought, offered, or permitted.

## **10. AMENDMENT OF BIDDING DOCUMENTS:**

At any time prior to the deadline for submission of bids, the Purchaser may, for any reason, modify the Bidding Documents by amendment in company website only.

The amendment will be notified in writing or fax or telegram or e-mail to all prospective Bidders, which have received the Bidding Documents and will be binding on them.

## **11. LANGUAGE OF BID:**

All correspondence and documents related to the bid shall be in English.

## **12. MODE OF SUBMISSION:**

EOI and all other documents shall be submitted in a sealed cover duly signed and stamped on all the pages along with all the documents proving eligibility with respect to Eligibility/ Qualification criteria and other relevant documents mentioned herein in Bid Documents.

## **13. BID VALIDITY:**

The BIDS quoted should be valid for 24 months from the date of opening of the Bid. The Bidders are bound to supply orders placed during validity of contract.

## **14. MODIFICATION AND WITHDRAWAL OF BIDS:**

- 14.1 Bids once submitted should not be modified. However in exceptional cases where modification is inevitable, the following procedure for the same should be adopted.
- 14.2 Modification will be permitted only if a written notice of the same is received by HLL prior to the deadline prescribed for bid submission.
- 14.3 The Bidder's modifications shall be prepared, sealed, marked, and dispatched as follows the Bidders shall provide an original and one copy of any modification(s) to its bid, clearly identified as such, in two inner envelopes duly marked BID MODIFICATIONS ORIGINAL and BID MODIFICATIONS COPY. The inner envelopes shall be sealed in an outer envelope, which shall be duly marked BID.

14.4 Bidder wishing to withdraw its bid shall notify HLL in writing prior to the deadline prescribed for bid submission. The withdrawal notice shall:

14.4.1. Be addressed to HLL at the address named in the bid data sheet and bear the Contract name, and the words BID WITHDRAWAL NOTICE. Bid withdrawal notices received after the bid submission deadline will be ignored and the submitted bid will be deemed to be a validly submitted bid.

14.4.2 No bid may be withdrawn in the interval between the bid submission deadline and the expiration of the bid validity period specified.

14.5 The purchaser may, at its discretion, extend this deadline for submission of bids by amending the Bid Documents or any other reasons, in which case all rights and obligations of the Purchaser and Bidder previously subject to the deadline will thereafter be subject to the deadline as extended, in our website.

Purchaser will not be held responsible for the postal delay, if any, in the delivery of the bidding document or the non-receipt of the same. Bids sent by Telex/Fax/Telegraph will not be accepted.

The company reserves the right to club or split the items of works, change the qualifying criteria at their discretion and to reject the bid or cancel the tender without assigning any reason thereof.

## **15. AWARD OF CONTRACT:**

HLL will make special MoU with the short listed firm along with mutually agreed financial terms.

Short listed firms should give performance security of 2% of the value of the total order with in 7 days from the receipt of supply orders.

## **16. ARBITRATION:**

All disputes and differences, whatsoever arising between the parties out of or relating to the construction, meaning and operation or effect of this contract or breach thereof shall be settled at Trivandrum, Kerala (India) in accordance with the Indian Arbitration Act-1996. The CMD of HLL or his authorized representative will be the sole Arbitrator in case of dispute. The award in pursuance thereof shall be binding on all parties. The arbitrator shall give reasoned award.

## **17. FORCE MAJEURE:**

As per international practice, Force Majeure clause shall apply for any unforeseen circumstances covering Acts of God only, namely Strikes, Lockout, Civil Works, floods, fire etc in which cases the supplier shall inform the purchase of such happenings, with-in 15 days and either party may be free to get out of the contractual obligations without any financial implications on the either side.

## **18. CONFIDENTIALITY:**

This contract, its provisions and existence as well as any commercial data including price or technical data and any information provided in accordance herewith to the other party shall be considered as confidential. Such information shall not be disclosed to any third party unless required by any applicable law or authorized in writing by the other party. All such information shall be used by the other party only for the performance of this contract.

The restrictions here-in-above shall not apply to any information generally available to public or received in good faith from a third party without restriction. The parties hereby agree to keep as confidential all documentation furnished or received by either party at any time in connection with this contract. This provision as far as practicable shall apply to all the concerned officers of either party. This clause shall survive upon termination of this contract.

## **19. OTHER CONDITIONS:**

- 19.1 Conditional offers not conforming to HLL's terms and conditions, descriptions /specifications mentioned herein shall not be accepted/ considered.
- 19.2 The supplier shall not have the right to assign to any party its rights and obligations arising out of this contract in connection with it without the prior written consent of HLL Lifecare Limited.
- 19.3 HLL Lifecare Limited reserves its right either to select or reject any offer without assigning any reasons.
- 19.4 Supplier to give a declaration that they have not been blacklisted by any Government organization, as per Annexure III and also that HLL Lifecare Limited has not suffered any losses or business reputation through them.

- 19.5 If any shortages are detected in the sealed boxes at the final destination, the supplier will be held responsible for the same. In such a case the supplier will have to make good of the loss or refund the payment for such quantity equal to its FOR- Delhi value if the payment is already made. If payment is not made, purchaser will have right to deduct the payment for equal FOR value corresponding to the quantity shortage.
- 19.6 The Purchaser (HLL Lifecare Ltd) reserves the right to sample check the consignment at the time of Delivery which will be re-taped and strapped at the suppliers cost only
- 19.7 The purchaser (HLL Lifecare Ltd) reserve the right to accept in part or in full any tender or reject any or more tenders without assigning any reason or to cancel the tendering process and reject all tenders at any time prior to award of contract, without incurring any liability, whatsoever to the effected tenderer or tenderers. Subject to above, the contract will be awarded to the lowest evaluated responsive tenderer/bidder.

## **20. TERMINATION FOR INSOLVENCY:**

The Purchaser may at any time terminate the contact by giving 45 days written notice to the supplier without compensation to supplier if the supplier becomes a bankrupt or otherwise insolvent provided that such termination will not prejudice to affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.
