6. Condom, being exempted from all taxes and duties, no tax need to be paid by the contractor while transporting the consignment enroute destination. The Company, along with each load, will give a Certificate to this effect. Therefore, no claim on this account will be entertained. In the case of other materials attracting ST/ED, necessary documents required shall be provided.
7. Freight rate for stations from/to the places indicated herein are to be quoted. Freight rate for stations from/to places other than what are indicated herein shall be fixed mutually then and there considering the distance to nearby station indicated herein. In such cases the agreed rate will be applicable. However, terms and conditions will remain the same for such destinations.

20. The contract is of special nature involving handling and transport of costly materials and as such the contractor will have to ensure complete safety in handling and transporting these items.
