**TERMS AND CONDITIONS FOR HIRING OF VEHICLES FOR  
OFFICIAL USE ON CONTRACT BASIS**

- 1) The tenderer must be the owner of vehicles. The vehicle should be new or registered after January 2013. Copy of the RC book to be enclosed along with the tender to prove the ownership and year of Registration.
- 2) An EMD of Rs.5,000/- (Rupees five thousand only) per vehicle by way of Demand Draft favouring HLL Lifecare Limited, Trivandrum payable Thiruvananthapuram should accompany the tender. Tender without EMD will be summarily rejected.
- 3) The rate should be quoted in the enclosed format.
- 4) An amount of Rs.10,000/- is to be remitted as security deposit by the successful tenderer, for each vehicle.
- 5) The Earnest money of successful bidder/s will be converted to Security deposit and they will be required to remit only the balance amount. EMD remitted will be forfeited if the successful tenderer withdraws after opening the tender.
- 6) The Contractor shall provide the vehicle along with driver having valid license and badge, if any, and keep the vehicle in good running condition.
- 7) The rates quoted shall include wages to the driver, cost of oil, fuel, taxes, insurance, service charges. The Contractor shall solely be responsible for compliance of statutory and non-statutory requirements involved in providing the vehicle on monthly rental.
- 8) In case of any accident the contractor would be solely liable and HLL will not have any liability for the damages or compensation.
- 9) The contractor shall bear the cost of all the maintenance work of the vehicle provided. In case, the vehicle cannot be made available due to breakdown, Inspection etc., the contractor shall make alternative arrangements to provide substitute vehicle of the same category.
- 10) The bidder should not offer vehicles which are already under contract with other units of HLL or with any other organization.

- 11) The drivers and vehicles should be covered by valid Insurance and the Payment of compensation in case of any accident or otherwise shall be the responsibility of the contractor.
- 12) No advance will be given for the service provided by the contractor and the payment will be made only on monthly basis on presentation of bill after statutory deductions such as Income Tax. The contractor should also ensure that minimum wages is paid to the driver and a certificate to this effect shall be submitted by the contractor along with the monthly bill. PF & ESI coverage as applicable shall be the responsibility of the contractor.
- 13) The charges for additional Kilometers, if any, will be paid every month at the rates finalized.
- 14) If the services of the contractor are not satisfactory, HLL Lifecare Limited reserves the right to cancel the contract after giving 30 days notice.
- 15) In case the contractor fails to provide the vehicle on any day, the same will attract penalty and the additional expense incurred by the company in this regard for engaging vehicles from alternate sources will be deducted from the contractor bill / Security Deposit.

Penalty will be as under:-

- a. TATA Indica /Vista - Rs.1000 / day
- b. Innova/ Tavera/ Scorpio/ Xylo - Rs.1200 /day
- c. Ambulance (Maruthi Omni) - Rs. 1000 / day

- 16) Failure to supply vehicles continuously for a period of seven days will be treated as breach of contract and the Security deposit will be forfeited.
- 17) The meter indicating the kilometer should be accurate and in working condition as per the regulation of the Regional Transport Authorities concerned. The kilometer reading will be recorded at the factory premises and kilometer for to and fro running to garage shall be fixed at the negotiation meeting.

- 18) Log book will be kept in Vehicle under the custody of the driver for recording the distances of journeys performed and will be verified on daily basis for settlement of monthly bill.
- 19) The driver shall fill in the Trip Sheet forms made available from the Security Gate.
- 20) The contract will be for a period of **THREE** years. The contractor shall provide the vehicles based on the requirement of the company.
- 21) On awarding the contract, the contractor shall execute an agreement with HLL Lifecare Limited to the effect in a stamp paper equivalent to Rs.100/- (Rupees One Hundred Only). The draft Agreement available with HR Department shall be fully understood by the tenderers before filling the tender.
- 22) The drivers of the vehicle should be well behaved and hold valid driving license. In case the company decides to change the driver, the contractor should provide substitute immediately.
- 23) The vehicles shall be provided for all the days including Sundays & holidays.
- 24) In the event of any dispute the same shall be referred to the Unit Chief, Peroorkada Factory, Thiruvananthapuram. The decision of Unit Chief in the matter shall be final and binding on all the tenderers/ contractors.
- 25) The rate finalized against the tender shall remain firm and valid for a period of **THREE** years from the date of work order and no revision/escalation will be considered except in the case of increase or decline in fuel price.
